Directions to Urbana Country Club

From Columbus: Take Route 70 West to Route 29 West. Follow to Mutual, turn at the second right - Mutual/Union Road to Route 36. Turn left on Route 36. Country Club is one mile on left.

From the North: Connect with Route 4 in Marysville. Follow Route 4/36 through Milford Center. 3 Miles on Route 36 turn right; follow for 15 miles. Country Club is on the left.

From the South: Connect to Route 68 in Springfield. Take Route 68 North to square in Urbana. Take Route 19/36 East. Take left at the hospital following Route 36 three miles to Country Club on the right.
