Administration Update **1. Governor's 'State of the State'; Confirmation Hearings**

Governor John Kasich's first 'State of the State' Address is set for Tuesday, March 8 at noon. The address will be presented before a joint session of the Ohio General Assembly, and will be streamed live online for real-time viewing (check availability at http://www.governor.ohio.gov/). The Governor's budget is due within a week of that date, on March 15, and as previous governors have used State of the State addresses to debut budget ideas, it is expected there will be some budgetary issues addressed regarding the planning underway for the biennium.

According to several news service reports, the March 15 budget will not include a restructuring of Ohio's various health and human services agencies. Among the charges given to the Office of Health Transformation* (OHT -- www.healthtransformation.ohio.gov) in the Executive Order creating it was a requirement to recommend a permanent structure for the state's health and human services agencies that supports the OHT's overall goal of improving care and reducing

costs. Such a proposal would not be seen in the March 15 budget, said OHT Director Greg Moody, but changes on a smaller scale will be. He explained at a meeting late last month,

"You will see proposals to restructure some of our programs and how they operate. We are not going to lead with a proposal to restructure the agencies. Part of the charge of the Office of Health Transformation is to recommend a permanent structure going forward. That recommendation is not going to be in the March 15 budget."

Confirmation Hearings

In other Administration news, Director Confirmation Hearings were held last week and will again be held early this month for Cabinet-level agencies under the umbrella of the Office of Health Transformation. These include the Ohio Departments of: Job and Family Services; Medicaid; Budget and Management; Developmental Disabilities; Mental Health; Alcohol and Drug Addiction Services; Aging; and, Health.

*On January 13 Governor John Kasich signed an Executive Order that created the Office of Health Transformation (www.healthtransformation.ohio.gov) to modernize the fragmented system of Medicaid in Ohio, to improve the quality of health services available, and to provide the best value to taxpayers. The Office's first priority is to develop common-sense reforms that address immediate budget challenges.

Local events provide opportunities for thousands of Ohioans with and without disabilities to learn more about each other's capabilities and possibilities. Following are just a few things in the works for March:

Lake County Area - Walk Promotes Understanding

Charlie Schulz, 25, who has Down syndrome, has a busy March planned. Among other things, he and his brother help educate the community about people with developmental disabilities during the annual 'Walk in Their Shoes' event at Perry High School. Students in the Perry Service Learning program organized this second annual event to promote understanding of people with disabilities, and raise awareness about the challenges they face.

Today, from 3 p.m. to 7:30 p.m., people from the Lake County community, including Perry, Madison, Painesville, Mentor, and Willoughby -- as well as from Cuyahoga County (Solon) -will be lacing up their comfortable walking shoes to help spread the word that "*Together* ..." everyone can achieve more. And all the way from Franklin County, the remarkable Ohio State School for the Blind Marching Band will be there with a flair, sharing their own special brand of musical talent and teamwork. Perry Service Learning program instructor Mark Soeder notes,



"It's a great way to build tolerance and acceptance in our community. We have more than 260 people registered!"

The Gliding Stars of Findlay will host their tenth annual Ice Show, '*Time Traveling with Gliding Stars*' on March 20 at The Cube, 3430 N. Main St. in Findlay, beginning at 2:30 p.m. Children and adults with disabilities participate in the annual ice show, which this year includes music from all of the previous shows over the past nine years. Gliding Stars is an adaptive ice skating program that uses equipment such as walkers and various skates to help individuals with special needs – "The Stars" – to perform and skate. Stars participate in weekly lessons and are paired with trained volunteers under the direction of skilled skating instructors. The program boasts 51 Stars from six surrounding counties and the Hancock County area. Tickets are \$5 and may be purchased in advance, or at the door the day of the event.

3. Seifarth Receives Senate Resolution Marking Retirement

Ohio Senate President Tom Niehaus and Senator Jim Hughes presented a Resolution to DODD Legislative Liaison Mark Seifarth at a ceremony on February 23 in the Ohio Statehouse Senate Chambers. Seifarth's retirement from the position was effective March 1, 2011. The resolution stated in-part, "Members of the Senate of the 129th General Assembly of Ohio are pleased to pay tribute to Mark Evan Seifarth on his retirement as the Legislative Liaison for the Ohio Department of Developmental Disabilities." It went on to say,...

" Mark Seifarth has shown how very much a conscientious, industrious person can accomplish, and he can be proud that his unflagging dedication to the DODD has inspired many who know him to devote themselves similarly."

The Proclamation also stated, "Commencing his career as an intern with the Legislative Services Commission in 1983, he also has served as the Executive Assistant and Legislative Aide to Senator Oliver Ocasek; acting team leader of Consumer and Legislative Affairs as well as Government Affairs Coordinator for the Ohio Rehabilitation Services Commission; and, Congressional Liaison for the National Council on Disability."

Ohio Developmental Disabilities Council 5. DD Council Seeks Applicants for Membership

The Ohio Developmental Disabilities Council is seeking applicants for membership terms to be appointed by Governor John Kasich beginning in October 2011 and ending September 30, 2014. Council membership for the three-year terms must comply with categories listed in the federal Developmental Disabilities Act. Openings this year are for the following categories:

- One individual with a developmental disability; and,
- One immediate relative or guardian of an adult with a mentally impairing developmental disability who cannot advocate for himself/herself.

All candidates for DD Council membership should have experience serving on committees, boards, or organizations. Experience concerning persons with developmental disabilities would be especially relevant. Applicants should have first-hand knowledge about the developmental disabilities community in Ohio.

According to DD Council staff, it is especially important that applicants have the time to attend six meetings per year, and actively serve on at least two committees. Each meeting of Council occurs over a two-day period.

Serving as a member of DD Council provides the opportunity to work in a collaborative manner with state and federal policymakers, state and local service providers, and individuals with developmental disabilities and their family members.



The DD Council advocates to improve the system of supports and services for individuals with developmental disabilities and their families, and it conducts grant activities for the same purpose.
