1. Ohio's Statewide DD Awareness Month Kickoff, and More

It was a record-setting crowd!

More than 500 participants representing at least 28 counties gathered in the Ohio Statehouse Atrium in Columbus on the morning of March 3, to celebrate *Developmental Disabilities Awareness Month*, hosted by the Ohio Public Images (OPI) and the Ohio Department of Developmental Disabilities (DODD). Traveling from all corners of the state, groups of individuals, families, caregivers and other direct service providers, as well as other professionals

in Ohio's developmental disabilities community arrived in downtown Columbus to join in the annual kickoff celebration. Considering the many crowds and rallies of recent weeks surrounding the budget and other issues, more than one speaker noted, "This is probably one of the *happiest* big crowds we've had down here for a while!" And, indeed, there was a lot of camaraderie.

Individuals with disabilities, employers, legislators, and other stakeholders in the developmental disabilities community enthusiastically participated in the kickoff program, and it was the most diverse and geographically-representative group ever to attend the kickoff, according to OPI Board members. OPI Executive Director Lon Mitchell welcomed all with a nod to the 2011 DD Awareness Month theme, "*Together*," observing,

"It would be difficult to imagine a more impressive place for us to gather together – the beautiful Ohio Statehouse. You know, as 'The People's House,' it belongs to all of us."

This year's program (see http://www.dodd.ohio.gov/ddawarenessmonth.htm) included people with disabilities and their employers, friends, and mentors – each celebrating self advocacy and the results realized in pursuing abilities and interests with the help of supportive families, staff, and local communities. Also addressing the group were speakers representing the Ohio General Assembly, and governmental agencies serving Ohioans with developmental disabilities.

Of special note this year were employers from large companies -- including Lowe's and Sam's Club -- who came to share thoughts on training and hiring people who have disabilities:

"I know this sounds a little corny, but what I'm saying is, 'Let's Build Something Together!'

I believe we are, and I believe we can."

Alan Cox, Human Resources Manager for Lowe's Findlay Distribution Center, comments on the 'Together' theme, which reinforces the ongoing Lowe's slogan, 'Let's Build Something Together' – a synergy not lost on the audience.

It was evident as each speaker and group headed to the podium ... gathered at the information tables ... and mingled among the majestic columns of the Statehouse Atrium, that the spirit of the event grew exponentially as stories and experiences were shared. *Together*, the more than 500 people who came to celebrate made a positive impact on each others' lives, and will then pass that potential on to others – yet to be encouraged by the progress that is poised to continue.

A Marvelous March Mix of Awareness Across Ohio

As in the March 2 issue of *Pipeline*, (Pipeline Volume 5 Issue 5) we share here another sampling of the many activities and events celebrating Developmental Disabilities Awareness Month across Ohio. We'll wrap up a look at the month in the March 30 issue.

Richland Newhope's Awareness Comes in All Colors

Fifteen Richland County students were selected winners of the Annual Richland County Third Grade Coloring Contest. The event is sponsored by Richland Newhope (Richland County Board of DD) as part of Developmental Disabilities Awareness Month. All Richland County third grade classes were invited to participate in the contest, using the 2011 statewide theme, "*Together*."

Contest participants were asked to color a picture featuring three children, one of whom uses a wheelchair. The picture contained the message, "In one way or another, everyone is a little bit different. When we work and play together, it makes life better."



Contest organizers received 562 entries from 15 schools. One winner was chosen from each school. Tim Ludwig, an artist and employee at Element of Art Studio/Gallery, helped select this year's winners, which marked the first time that an individual who receives services from Richland Newhope assisted with judging the contest.

Winners received a certificate, art supplies, a bookmark with their name in Braille, a magnifier, and a button designed by an individual served by Richland Newhope. Mount Vernon Developmental Center & Knox County DD Join Forces

At the Mount Vernon Developmental Center (MVDC) on March 2, nearly 130 people representing a broad cross-section of community partners, service providers, and individuals with developmental disabilities, attended a DD Awareness Month Luncheon sponsored by MVDC and the Knox County Board of Developmental Disabilities (KCBDD).

The group was welcomed by MVDC Superintendent Ernie Fischer, who spotlighted this year's theme, "*Together*." Noting that 'Together the Future is Brighter,' Fischer reinforced the theme, adding that individuals with disabilities are, "...Our neighbors, co-workers, classmates, and friends. They can achieve great things with the community's support."

The luncheon included awards presented by KCBDD Superintendent Steve Oster, and a keynote speech by Stephen Douglas, Ph.D., who talked about his life experiences to illustrate how one's approach to life has the potential to brighten the lives of many others. MVDC and the Knox County Baord work collaboratively on many community efforts, building on the Developmental Center's strengths as a community resource for needed services and information, and the County Board's local approach to and expertise in meeting the needs of area citizens with developmental disabilities.

Knox County Commissioners presented a Resolution recognizing Developmental Disabilities Awareness Month and the positive impact persons with developmental disabilities have had locally, with the support of the Knox County community. The Stark County District Library and the Stark County Board of DD are partnering in a spring celebration of Developmental Disabilities Awareness Month. A "Spring has Sprung!" art exhibit will be featured at the Main Branch Library, March 8 - 31. All of the art has been handcrafted by artists employed by The Workshops Inc., in collaboration with The Stark County Board of DD.

Artists 'went green' this spring and used all recyclable/ reusable products. Papier-mâché, clay, paint, cardboard tubes, and old pop bottles became furry critters, flowers, rainbow fish, and trees. According to Debbie Kempthorne, workshop specialist at the Stark County DD Whipple-Dale Centre's art program, "The art is all about the individuals and what they have inside."

Over a two month period, adult artists worked together, side-by-side, to complete the art projects – sharing ideas, paint brushes, and inspiration, and all the while encouraging one another.





"It all came from up here," she explained, while smiling and pointing to her head.
"I worked on the bird and the art coloring," said Jennifer Nuske, an artist working for The Workshops Inc. "The bird is so cool. I just picked a color. I thought red is really nice. I added gold to the legs because they looked plain. I thought red, white, and gold were pretty – they looked like socks. My favorite part was the painting."

Linda Dahl, Public Information Manager for the Stark County District Library, added, "What better way to illustrate this year's Developmental Disabilities Awareness Month theme of 'Together' than for the library to work with the Stark County Board of Developmental Disabilities to bring this show to the public!"

Administration Update

2. Governor Kasich and the Office of Health Transformation Move Forward on Agenda

A new state law takes effect this month that will help more older adults stay in their homes and out of nursing facilities. According to a news release from the Ohio Association of Area Agencies on Aging, "Starting Saturday, March 12, older adults who are discharged from hospitals, live in unsafe conditions, or have depleted their assets for assisted living will have immediate access to home care, eliminating any wait lists for PASSPORT and other services if they should occur." The release continues,

"The law expands Ohio's *Home First* policy and overcomes a major barrier to receiving home and community care by doing away with government-imposed wait lists that controlled enrollment in these programs in the past. Many older adults are placed needlessly in expensive nursing facilities for services they could easily receive at home and at less cost, including personal care and assistance with meals."

Ohio's 12 area agencies on aging will administer the policy, known as *Home First*. The new *Home First* expansion passed unanimously in both the Ohio House and Ohio Senate last June.

Keeping Ohio's seniors in their own homes was one cost-cutting measure highlighted in Governor Kasich's State of the State address (see 2011 State of the State) and it has been estimated that providing services at home reduces costs for long-term care by one-third. For example, the state pays about \$20,000 annually to care for a person at home, compared to \$62,000 annually at a nursing facility.

Senate Health, Human Services & Aging Committee, Director Confirmation Hearings

On March 9, the Senate Health, Human Services, and Aging Committee heard presentations from three Department Directors: Orman Hall, of the Ohio Department of Alcohol and Drug Addiction Services (ODADAS); John Martin, of the Ohio Department of Developmental Disabilities (DODD); and Tracy Plouck, of the Ohio Department of Mental Health (ODMH). Confirmation hearings for each Cabinet-level Director within the purview of the Committee have now been held.

ODADAS Director Hall observed that, "Substance abuse and addiction are embedded in many of the serious challenges facing the State of Ohio today." He focused specifically on addictions to

opiates and heroin, and said that addressing this epidemic will be the agency's 'priority number one' moving forward.

DODD Director Martin, noted that the Department has reduced the GRF for Central Office administration expenditures by 43% over the past few years, and expressed the Department's enthusiasm for working collaboratively with the newly-created Office of Health Transformation and partnering health and human services agencies. He stated, "We appreciate the Administration's demonstrated interest in Ohio's developmental disabilities community, and we look forward to continuing to build strong relationships with our OHT partners."

ODMH Director Tracy Plouck explained in her presentation that the mental health system's financing structure, established in Ohio's Mental Health Act of 1988, "...Must be transformed immediately to address a number of significant and growing pressures that render the status quo unsustainable." To that end, ODMH will be leading the Office of Health Transformation effort on integrating behavioral and physical health services.

Ohio Respite Summit

3. Respite is the Key to this Story

Defined as, "An interval of temporary relief or rest," *respite* is the most often-mentioned need cited by families and caregivers of individuals with developmental disabilities. And the Ohio Respite Summit is seeking ways to improve and strengthen respite options within the state by learning more from the people who know most about it.

According to DODD Family Advocate Peggy Martin, "I support the Ohio Respite Summit because after many years in this position, I know that the service most needed and most requested by families is *respite*!" She continues,

"I strongly believe that families experience a higher level of family stress when raising a child who has a disability. If a family can get a break or have time for other members in their family they are able to cope better. Family caregivers need a break and we need to invest in respite so that we don't end up seeking residential settings for families because they find they just 'can't do it anymore.' A little break can make a world of difference!"



At the Ohio Respite Summit meeting earlier this month, hosted by the Arch National Respite Network and Resource Center (www.archrespite.org) discussions gave way to breakout sessions and lots of input on 'Lifespan Respite' (click on The Purpose of the Program and How it Works) by families and caregivers. While much information is available at the links noted here, the shared stories are what will most often drive the system and empower the individuals served. Here is one such story ...

Lynne's Story

Good morning. My name is Lynne Fogel. I am the mother of two beautiful girls - Erica is 9 and is diagnosed with cerebral palsy, and Natalie is 5. I am also blessed with a wonderful husband who takes an equal share of the caregiving responsibilities for both of our girls.

Erica's CP is of the spastic quadriplegic variety, which means that she requires full assist for all activities of daily living. I feel that in being a parent and advocate for her, I wear the hats of mom, therapist, teacher, tutor, cheerleader, secretary, and sometimes pack mule. Every departure from the house with her in tow takes four times longer, and many errands go undone because it just isn't worth the effort to take her along.

When respite happens, it sometimes gives me a feeling of turbo-charged productivity. If someone is at home working with Erica on school work while I am out running important errands, I'm not only getting my to-do list checked off but I won't have the homework to deal with when I get home!

Other times, respite gives me some actual alone time, which for me is in short supply and I cherish. When a provider takes Erica to therapy appointments for me and my preschooler is occupied in another part of the house, I've been known to... dare I say it?... read a magazine. Oh, such indulgence!! But whether I am cranking out chores or enjoying some peace and quiet, I end up feeling energized and re-charged, which benefits my children as well.

I am a better mom when I feel like I am accomplishing what I need to and not feeling harried, stressed and overwhelmed.

I am fortunate in that my daughter's caregivers are people who love her. She has a way of making you fall for her, but knowing that these important people in her life not only care about doing a job well, but truly want what's best for her in every way is simply wonderful for my peace of mind.

We have a Level One waiver for Erica, and thus far that has provided enough of a budget for the number of respite hours we use. I can foresee, however, that the future will bring more opportunities to utilize respite ... (more in Pipeline Quarterly, coming soon!)

4. Best Practice Provider and County Board Selections Announced

The Ohio Provider Resource Association (OPRA) and its system partners announced the selection of six groups to participate in a study to determine the *best practices* of providers and County Boards serving Ohioans with intellectual and developmental disabilities. The study is funded by a grant from the Ohio Department of Developmental Disabilities (DODD).

The goals of the project include improved consistency of care, statewide; role clarification among staff; and, enhanced involvement of individuals and families.

"The response to participate in this important study was great," said Mark Davis, OPRA President. "We had a difficult time selecting from the many quality providers and County Boards."

The selection panel considered many factors when selecting the counties, including: relationships between all stakeholders; tenure of leadership; history of working through challenges; size of counties and providers; geographic diversity; and, service array offered.

Those selected and listed below include those who have made a *strong initial commitment* at the time of application to work together on this project. Additional providers, along with individuals with disabilities, family members, and others also will be invited to participate in this study.

- Clearwater COG -- (Includes Broken Arrow, Christie Lane Industries, Crawford County, Huron County, Marion County, Renaissance House, RHAM, Wynn-Reeth)
- Cuyahoga County -- Grand Manner, Koinonia
- Guernsey County -- Guernsey Residential
- Hamilton County -- Ohio Valley Goodwill, Ohio Valley Residential Services
- Knox County -- Creative Foundation, New Hope Industries
- Miami County -- Champaign Residential Services (CRSI), Vision Mentors

Selection panel member Lori Stanfa, Ohio Association of County Boards, noted, "We were overwhelmed by the responses, and want to thank everyone who took the time to submit an application. This speaks very highly of the commitment to best practices in our field."

Increased Emphasis on Government Relations

In other news at OPRA, the agency last week announced the hiring of Jeff Davis as its new Director of Government Relations. Davis most recently served as Director of Integrated Health Services for Buckeye Community Health Plan. Prior to that, from 1991 to 2007, Davis was a Deputy Director at the Ohio Department of Developmental Disabilities.





5. The IWGA Wants to Hear from Ohio's Families

The Interagency Work Group on Autism (IWGA), convened by the *Ohio Department* of Developmental Disabilities, coordinates efforts among state agency partners so that the gifts, talents, wishes, and needs of Ohioans with Autism Spectrum Disorders are recognized, valued, and addressed.

Across the nation, there are many different kinds of general interventions and therapies being researched and developed to help individuals with Autism Spectrum Disorders (ASD) grow, learn, and pursue a high quality of life.

To learn about what kinds of interventions and therapies Ohio families are using for their family member with ASD, the IWGA has created a brief online survey at www.autism.ohio.gov.

The survey asks families about their experiences with eight different general intervention/therapy approaches. The information collected will help develop a picture of the kinds of intervention approaches Ohio families are using throughout the state, and will help guide the work needed to assure that *useful* information about effective interventions/therapies gets into the hands of families and service providers, statewide.

The survey will remain online through the month of *April – National Autism Awareness Month!*

▶ LEGISLATIVE ADVOCACY DAY – APRIL 14

Legislative Advocacy Day 2011 will be April 14, 2011 at the Ohio Statehouse. Sponsored by the Ohio Developmental Disabilities Network, the event will include a brief program followed by appointments with legislators to discuss subjects of importance directly with those who can move those concerns and ideas forward. The Ohio Developmental Disabilities Network consists of the Ohio Developmental Disabilities Council ('DD Council'), Ohio Legal Rights Service, and the University Centers for Excellence in Developmental Disabilities at The Ohio State University Nisonger Center and at the University of Cincinnati. About 325 advocates from throughout Ohio attended the Legislative Advocacy Day at the Statehouse last September.

Self advocates, families, and professionals in the developmental disabilities community are encouraged to come together and talk with legislators about why home and community-based services are important to people with disabilities as the state shapes the biennial budget. Ohio Developmental Disabilities Council Seeks Membership Applicants
