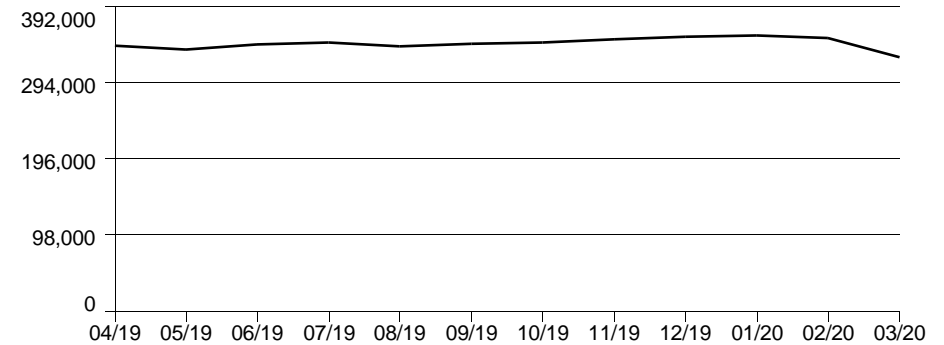

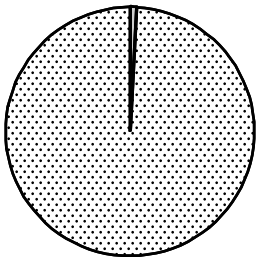

Cash and Sweep Balances
