December Market Commentary

The major averages closed out December near record highs, as vaccine optimism and the passage of a long-awaited fifth coronavirus relief package buoyed investor sentiment. The S&P 500 climbed 3.7%. The Nasdaq Composite jumped 5.7%, capping the best year for the tech-heavy benchmark since 2009 (+43.6%). The Russell 2000 index of small-cap stocks outperformed with an 8.2% monthly rally, while the Dow Jones Industrial Average trailed its domestic peers on a relative basis with a 3.3% advance in December. On the vaccine front, U.S. regulators approved two COVID-19 inoculations for emergency use authorization by month-end, and began to distribute doses to frontline healthcare workers. The rollout of the vaccine helped investors overlook not only record coronavirus infections and hospitalization rates, but also fresh lockdown restrictions in the U.S. and abroad. Meanwhile, lawmakers in Washington passed a long-discussed fiscal stimulus measure, which extended additional federal unemployment benefits and provided a \$600 stimulus check to most Americans. Geopolitical updates from across the pond gave investors another reason cheer, with the European Union and the United Kingdom reaching a post-Brexit trade deal just days before the British were set to leave the European bloc.

Meanwhile, data updates provided a reminder that, despite stimulus and vaccine optimism, U.S. economic activity may be stalling amid worsening coronavirus trends. A report showed that U.S. retail sales dipped 1.1% in November. The data for October was revised to show a small decline, marking the first monthly drop in consumer spending since April. The monthly jobs report also disappointed, with the U.S. economy adding 245,000 non-farm payrolls in November, which was below consensus estimates for 460,000. However, the Treasury yield curve steepened during the month as lawmakers and central bankers continued to signal support for the economy.

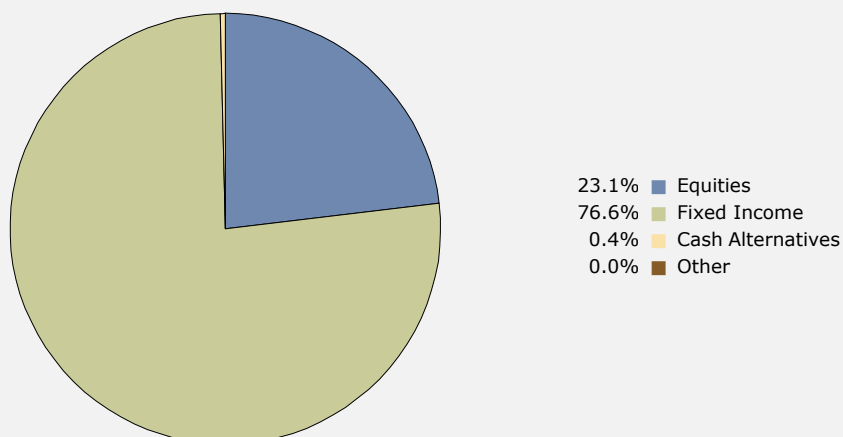

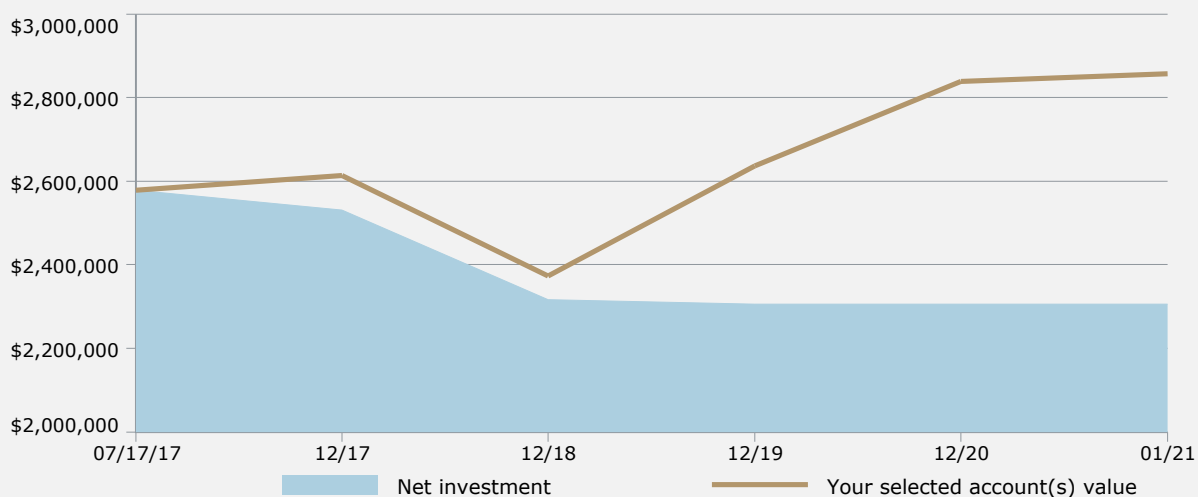
Asset allocation

Value versus net investment

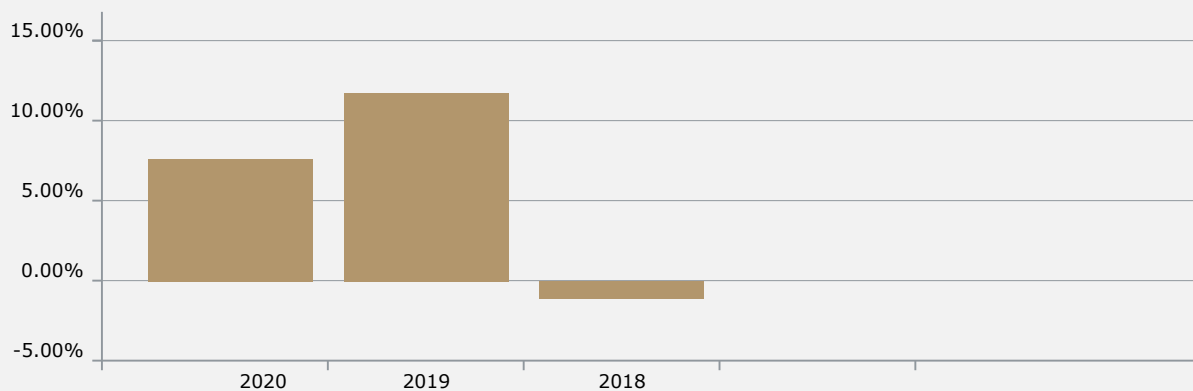

Investment objective/Risk tolerance

Trading & Speculation - Trading and Speculation investors seek out maximum return through a broad range of investment strategies, which generally involve a high level of risk, including the potential for unlimited loss of investment capital.
