March 23rd, 2022

Call to Order and “Safe Place” statement

- Adam Guinther called the meeting to order at 10:00 am. Adam reviewed the safe place statement.

Board Minutes

- Liz Owens motioned to approve the minutes from the January meeting. Scott DeLong seconded. Motion carried.

Financial Report

- Liz Owens reviewed financial reports sent out to the Board Members. Mary Thompson-Hufford motioned to approve the financial report. Michelle Madden seconded. Motion carried.

Governance Committee update

- Bob Gaston, chair of the Governance Committee, gave the committee’s report.
 - **Board Elections-** Two Board Members are retiring in April- Roger Fortener and Laura LaGodney. A special election will be held.
 - Roger and Laura are also on the Executive Committee. An online survey has been sent out to Board Members to vote on the replacement.
 - **Self-assessment-** If you have not completed the self-assessment, please submit those ASAP.

Board Report

- Pete Moore with assistance from the OPRA staff
 - **State Biennium Budget-** Pete shared the foundations of a proposal for the next state biennium budget. The proposal was initially shared with the Policy Core Committee and revised based on the Core Committee’s feedback. More information will be coming at future meetings.
 - Pete addressed a recent public records request on county board funding and the intent behind the ask.
 - Pete discussed strategies to address short-term provider sustainability needs being proposed by OACB and different county boards of DD (revision of the longevity add-on)

- 14c Discussion: Pete, Scott, and Christine gave an update on the coalition that is working on proposed state legislation that would eliminate the use of 14c certificates in Ohio on 1/1/23.

- Liz Owens made a motion to oppose the proposed legislative language on eliminating the use of 14c certificates proposed by the coalition. Phil Miller seconded. Motion carried.

OPRA Board Committees

OPRA has numerous committees to ensure the proper operation and oversight of the organization, to engage its members, to support members to perform optimally, and to maximize member value proposition.

Board level committees:

Four committees have been established by the board to perform board related work and oversight. These committees are typically comprised exclusively or predominantly by board members. All members are assigned by the board of directors and report directly to the board:

1. **Executive Committee:** Board Chair, Vice Chair, Secretary and Treasurer are the members of the executive committee. The executive committee performs work on behalf of the board, as designated and reports back to the full board. The executive committee has no decision-making authority outside of that specifically delegated by the board. The exception would be decisions that must be made between board meetings and those decisions will be ratified by the board at its next meeting.
2. **Finance Committee:** The board Treasurer chairs the finance committee. Other members are assigned by the board chair. The finance committee is staffed by the CEO and the bookkeeper attends as requested. The finance committee reviews monthly financial statements, reviews and recommends an annual budget to the board for approval, and oversees the organization audit or financial review.
3. **Membership & Services Committee:** The membership & services committee oversees membership engagement, membership renewal process, ensuring member satisfaction with OPRA's value proposition, oversees orientation of new members, and conducts research and creates unique partnerships to give OPRA members a variety of pre-screened products and services that ensure quality and competitive/preferred pricing. This committee is chaired by a member of the board of directors, as assigned by the board chair.
4. **Governance Committee:** The Governance Committee shall be appointed and conduct its affairs in accordance with Section 4.3 and Section 5.3 of the Code of Regulations. The Governance Committee is responsible for recruiting and developing Board leadership, Board composition, Board effectiveness and conducting Board membership and Officer elections. The Governance Committee shall have such other duties and powers assigned to it by the Board of Directors.

5. **Policy Committee:** The policy committee serves as the clearinghouse for most issues affecting any aspect of DD services, and makes recommendations for action to OPRA's board of directors. Every effort is made to allow sufficient time to discuss issues in detail in order to understand the impact on individuals and providers, and to consider what position OPRA should take on a given issue. Ad hoc workgroups are established from time to time to examine issues more fully. The policy committee is chaired by the vice chair of the board of directors with a representative provider group selected to serve as the core committee. This core committee is tasked with convening and commenting on policy issues as they arise, whether during a meeting or between meetings. Other committee work flows through policy committee to the board of directors, and vice versa.

Policy Committee

The policy committee serves as the clearinghouse for most issues affecting any aspect of DD services, and makes recommendations for action to OPRA's board of directors. Rule Discussion

Christine Touvelle, Scott Marks, and Rachel Hayes provided updates on a number of rules that are up for a public hearing next week. The rules discussed were:

- Waiver simplification under the SELF waiver and level 1 waiver
- Self-directed transportation
- Behavior support
- Waiver nursing delegation

Biennium Budget Discussion

- **"The Coalition"** is made up of 5 trade associations (OPRA, OACB, OHCA, OWN, and the Values and Faith Alliance). The Coalition was in place during the last budget but it is anticipated, due to the serious and dire state of our system, the relationships between all of the entities is going to be crucial. The Coalition is also in the process of identifying other key partners who are close to our system including but not limited to The Arc of Ohio, The Superintendents' Association, the Ohio Self-Determination Association, etc.
- **Historic Asks** Because of the severity of the crisis the requests that we put on the table will be historic in nature, rate increases that have not been seen before and system reform efforts that

have been needed for a long time. This will include strategies on how to integrate County Board funds in a long term sustainability strategy.

- **Start with the Governor's Budget proposal** It is important that we make the effort with the administration to try to get at least a portion of our ask included in the Governor's proposed budget. This will provide us with a good starting point as we begin discussions with the House and Senate.

Funding and Reform



Current Funding Ask Proposal

The current biennium budget proposal is not finalized. There are a few more items we need to clarify before we finalize “the ask”. The Policy Core Committee had a good discussion about the current budget proposal. The focus is on funding frontline professionals (DSPs, frontline staff, nursing, any other person who can support a person with DD).

Scott presented a excel worksheet to the committee showing how the ask was developed. An increase in rates for all waiver and ICF services of about 45% equaling \$447M per year in state match for each year which would help support a roughly \$19/hour wage. There was a lot of discussion about “the wage” and what “pure wage” we should start with to determine the total ask. For example, \$19/hour is not a pure wage if we don’t cover Employment Related Expenses (ERE) and overtime in our calculations above and beyond the target wage. There were many concerns about how overtime would eat away at the wage.

There was also a lot of discussion about making sure that all stakeholders are using the same terms as we begin to advocate during the budget process. We have tossed around terms like a “minimum” or “base” wage and those terms may not reflect what we are trying to achieve. It was suggested that we develop a glossary of terms and work with the stakeholders to use a consistent language when talking to legislators and other stakeholders as we garner support.

Concerns were raised about the message about budget and wages is shared with staff, county boards and other stakeholders. This stems from budget increase that were implemented in 2020 and how the message was in the system that all DSP’s would make a certain dollar amount per hour. This misinformation spread quickly and it created confusion and conflict. We want to be sure that the message conveys the reality of any increases providers will receive. We also want to make sure stakeholders understand the need to address wage compression issues and that a portion of the funds we are able to get will address that issue.

We are going to take the feedback we received to the coalition for consideration.

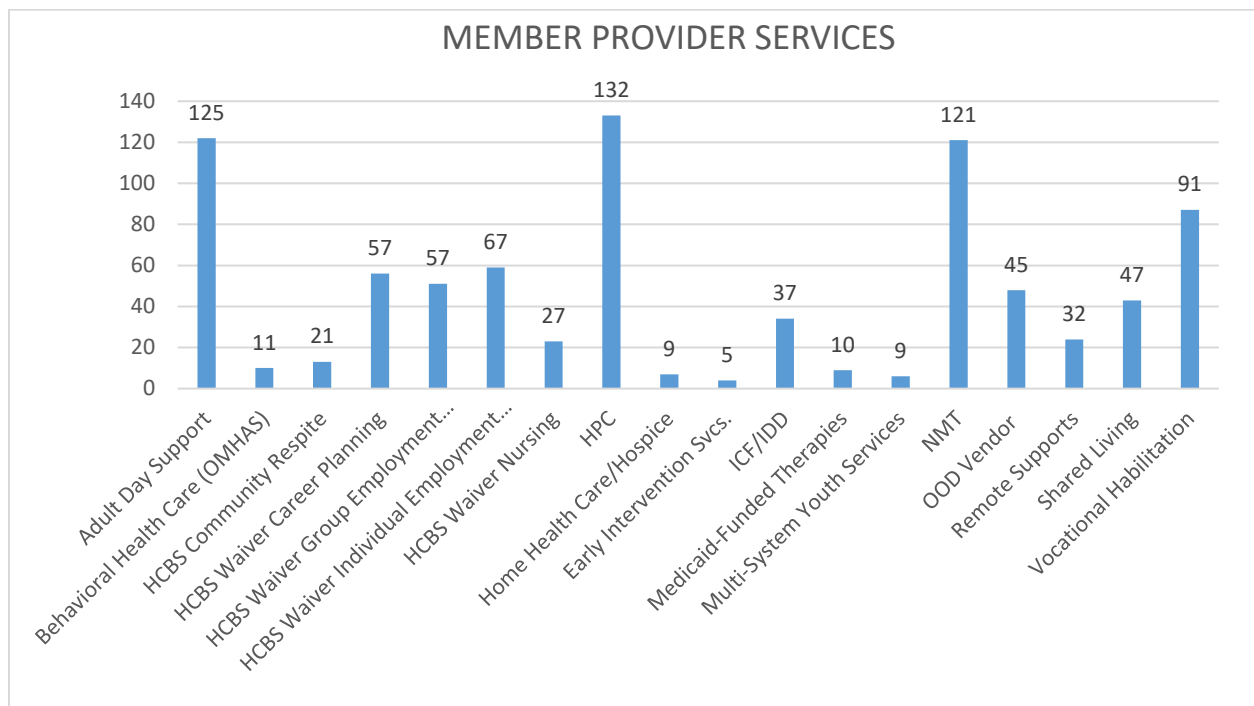
