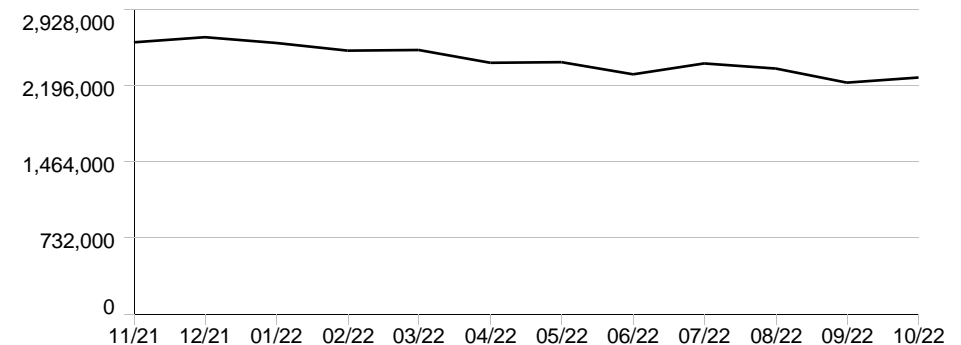

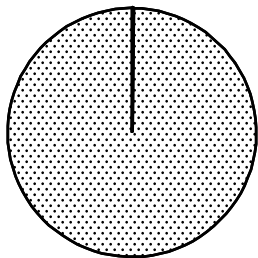

The money market mutual funds in the sweep reserve the right to require one or more day's prior notice before permitting withdrawals.
