One in three Ohio children rely on Medicaid for health care coverage, and as the state's largest Medicaid providers with an average of 51 percent of our patients relying on Medicaid, we look forward to working closely with Ohio lawmakers, Governor Kasich's administration and, specifically, Ohio Office of Health Transformation Director Moody and Ohio Medicaid Director McCarthy to ensure that the state budget places a high priority on our state's children and their short and long-term health care needs.

These programs, coupled with health insurance for low income Ohioans, some of whom struggle with untreated mental health disorders, will go a long way toward addressing the needs of many of our state's must vulnerable citizens," said Terry Russell, the Executive Director of the National Alliance on Mental Illness of Ohio. "NAMI Ohio is grateful to Governor Kasich for prioritizing mental health during his first four years in office and right now it looks like the next four years will be much the same."

Shelly Kiser, spokesperson for Investing in Tobacco-Free Youth Coalition - "We applaud Governor Kasich's bold proposals that will lead to significant reductions in tobacco use in Ohio. The proposed increase in the cigarette tax by \$1.00 per pack will reduce youth smoking rates by 12 percent and will help more than 73,000 Ohioans overcome their addiction to cigarettes.

Governor Kasich also proposes to increase the tax rate on other tobacco products like chew, snuff, and cigars to match the rate on cigarettes. Raising the other tobacco products tax will help ensure that kids don't turn to or start using these products because they are cheaper.

Additional policy proposals to make Ohio's school and college campuses tobacco-free promote social norms that encourage healthy living and lifestyle choices. These policies support students and employees on college campuses who are trying to quit but also dissuade young adults from starting to use tobacco products.

The savings to the state will be great. The five-year costs savings to the Medicaid program will be more than \$15 million. The long-term health care cost savings will reach \$2.7 billion. Fewer low birthweight babies, less cancer, fewer heart attacks, preventing 40,100 premature smoking-caused deaths— priceless.

We thank Governor Kasich for making tobacco prevention and cessation a priority in his budget."

Marcie Seidel, Executive Director, Drug Free Action Alliance - Drug Free Action Alliance extends its support for Governor Kasich's budget proposal. With an emphasis on not only the financial health of the state, but also the health of Ohio's citizens, we believe that this budget proposal can help improve the overall financial, mental and physical health for all Ohioans. Governor Kasich's budget calls for the re-authorization of Medicaid, which has already provided essential healthcare for over 470,000 additional Ohioans, so that children and families can reach their potential keeping Ohio's future bright. We also are in full support of the additional tax to tobacco products, which costs taxpayers \$289 billion in lost productivity at work and health-related consequences from tobacco products in the US, according to the Centers for Disease Control and Prevention (CDC). Research has consistently shown that higher taxes on cigarettes and other tobacco products reduces smoking rates in adults, which leads to better health, and it also is a barrier to children taking up this deadly addiction.

MetroHealth knows first-hand that healthcare works to transform lives. During the MetroHealth Care Plus pilot program, which was an early version of this coverage, we found many enrollees were the working poor, often struggling to find coverage and maintain health.

After providing access to coverage, we found health outcomes were improved and costs were significantly lower than estimates. In fact, many were accessing essential services such as dentistry or behavioral health for the first time in years.

While there is a lot that the budget proposes in the way of reform, it is critical that coverage be continued so that reform is possible. MetroHealth appreciates the Governor's steadfast support on this issue and look forward to a partnership that makes all of our communities healthier.

The Ohio State Medical Association - "Two years ago the Ohio State Medical Association supported the expansion of Medicaid as a crucial tool for increasing access to healthcare for numerous Ohioans who were either uninsured or otherwise unable to see a doctor for medical care. AIDS Resource Center Ohio - (Ohio) AIDS Resource Center Ohio (ARC Ohio) extends its appreciation and support for the State of Ohio's new budget. The proposed continued funding and coverage for some of Ohio's most vulnerable citizens is critical to ARC Ohio's work and provides tools and resources that will help reduce the rate of new HIV infections in Ohio.

In Ohio, there are 1,000 new HIV infections each year. The Centers for Disease Control (CDC) estimates that every HIV infection averted saves \$379,668 (in 2010 dollars). Research currently demonstrates that deferring treatment or preventing access to antiretroviral medication results in greater long term costs for the state at-large.

The latest medical studies have demonstrated that viral suppression is key to an effective public health strategy and is critical to reducing the rate of new HIV infections. The use of antiretroviral therapy reliably prevents HIV transmission over an extended period of time by up to 96%. Furthermore, it costs about one third as much to help patients achieve and attain viral suppression as it does to treat those who do not have their HIV disease under control. Continued funding for coverage for persons with HIV increases access to therapy, reduces costs for care, saves tax payer dollars, and reduces the rate of new HIV infections in the state.

After 30 years of service to the state of Ohio, ARC Ohio knows that healthcare truly works to transform lives. We believe in the benefit that medical care coverage affords those individuals who need it most and appreciate Governor Kasich's efforts to support funding and coverage.
