

□ Focus- On the job supports/services (also includes AT, benefits)

Reimbursement based on the following stages:
 Initial/Intense (i.e., time-limited/not long-term supports to help learn/become stable on job)

Stabilization (i.e., regular contact w/person and/or employer)

□ Maintenance (i.e., 1x/month, on/off site, monthly payment, incentive to stay engaged/connected)

Non-Medical Transportation

□Services delivered in facilities – to/from only

□Integrated community services – incentive -- address per-trip vehicle and/or per-mile rate
