Tim has been a part of the field of intellectual/developmental disabilities since 1991 when he served as a camp counselor at Camp Echoing Hills. Tim's life mission statement is to *serve, love, and lead the marginalized and disenfranchised of society to live a fulfilled and enriched life*. Tim received his bachelor's degree in business management from Pensacola Christian College and his master's degree in business and strategic leadership from Roberts Wesleyan College.

Tim's appointment to the OPRA Board of Directors in May 2023 to fill an At Large Director seat is a testament to his leadership and commitment to the field. His involvement with the OPRA Board of Directors, Pete Moore, and the OPRA staff has been a fulfilling experience in making the association the leading provider association in Ohio.
