Special Training Needs: Med Cert I

Service needs: All three women use a wheelchair and will need accessible transportation. One can walk short distances with assistance and it is important for her to do so to keep her strength in her legs. All three women have guardians, payees, and special dietary requirements for consistency and allergies. Two staff are required for transfers of one individual and there is Hoyer lift in the home to assist with transfers. Each person uses her own communication other than verbal, including basic sign language. Each person requires total assistance with medication administration and ADLs.

Residents: 2 adult men **Type of Service:** HPC

Hours: 24 hours (no OSOC), Staffing need 1-2 staff per day

Special Training Needs: Med Cert I

Service Needs: This is a house that likes to get out and go! One of the men is a social butterfly, communicating primarily with gestures and facial expressions, and loves to be on the move. He likes to walk around the neighborhood, go to parades and festivals and listen to music. He likes to go to choir practice at church and dance along with the singers. He needs support with all home and personal needs and likes a support person talking him through each step of the process. The other person is gentle and quiet. He knows some sign language, but primarily uses hand gestures and occasional leading. He is happy to hear his name in conversation and can be very empathetic. He may try to comfort his roommate or favorite staff with arm strokes. He loves going out for dessert or enjoying a ride around town and will run to the van in excitement.

Residents: 4 adult women **Type of Service:** HPC

Hours: 24/7, Staffing need 2-4 staff per day.

Special Training Needs: Med Cert II

Service Needs: Four roommates are in need of an HPC provider. This home requires an accessible vehicle for four wheelchairs. Though one of the women can get around with some assistance, she uses a wheelchair when she goes out. All four women have a number of medical needs that require close monitoring and consideration necessitating a high level of supervision. In the event of an emergency, two of the women need staff to ride to the hospital with them or meet them there. Two of the women are fed and/or receive medication via G-tube and one via G/J tube. The fourth person requires assistance and monitoring to ensure safety while eating. Staff persons who are patient, willing to verbally navigate the world for the person and repeat information would be best here. These women are a combination of vibrant personalities that includes loving to shop, picking out their own clothing and jewelry, loving attention, being outgoing, and talking about their day and upcoming schedule. Total assistance with personal care and ADLs as well as transfers will be required. Some assistive equipment is in the home to aid in care, such as a mechanical lift, shower chair, and Hoyer lift.
