Provider Certification: On Sept. 25, stakeholders convened for the 6th meeting of the provider certification workgroup. The primary issues discussed were the training requirements for CEOs and DSPs, as well as the "Direct Support Assistant" role, that could potentially be filled by 16 and 17 year old staff. IT Workgroup: On Friday Sept 20, DODD's Information Technology workgroup met to discuss and provide updates regarding the IT systems updates needed to implement the HPC rate increase in January of 2020. As of now, the updates are on track to be completed by October 1st, allowing 3 months for any necessary authorization changes to incorporate the new rates. There is great hope among the group that much of this process will be automated, alleviating the need to individually update authorizations statewide. To read more, click here.

Rule Clearance: DODD provided OPRA and other stakeholders with responses and rule updates based on clearance comments made to the revised Non-Medical Transportation and HPC: On-site/On-Call services. Due to OPRA's advocacy during the clearance process, revisions were made to the NMT rule, expanding the definition of a modified vehicle. Both of these rules are expected to be filed in mid-October. DOL Overtime Rule: Yesterday, the Department of Labor announced the revision of the DOL Overtime Rule of the Fair Labor Standards Act (FLSA). After soliciting input from the general public, the Trump administration is raising the threshold to \$35,568 per year for a full-time worker, going into effect on January 1, 2020.
