Ancor Policy and Hill Summit: OPRA Staff and members were in Washington DC this week for a jam-packed day of hill visits and learning. Our team met with the offices of Representatives Joyce, Kaptur, Stivers, Gonzalez and Jordan to discuss the issues facing disability service providers in Ohio. In addition to meetings with Senator Brown's office, our team helped to present an Ancor Award to Sen. Rob Portman. Congratulations to OPRA/CRSI's Than Johnson, who was presented an award by ANCOR for his many contributions and advocacy over the years. We look forward to continuing our conversations with legislators as we monitor federal legislation concerning HCBS infrastruture and waiver services during hospital stays. Statewide Single Plan: On Oct. 16, the statewide single ISP workgroup met to continue work on the standard assessment to be used by SSAs and QIDPs to inform the content of the single plan. The current draft assessment, which began the meeting at 85 pages, will need to be considerably streamlined and simplified before being ready to pilot. OPRA will continue to work with DODD and other system stakeholders to ensure this work leads to simplification, and a more consistent process for providers throughout the state. EVV: Earlier this week the Ohio Department of Medicaid held their monthly stakeholder meeting. They reviewed utilization data, new reports available, and changes to the alternate vendor communication and certification process. You can find the presentation from the stakeholder meeting here. ODM will also be presenting webinars on the Oct 22nd and 29th that will explain these changes. Christine will be sending a comprehensive email this afternoon, fully detailing the important updates outlined in this week's Stakeholder meeting.

Rules Filed: This week, many of the rules we have been following since the biennium budget were filed. Those rules include updates to NMT, Transportation, and HPC-On-site/On-call.
