Wage and Benefit Survey: Planning has begun for our 2020 Member Wage and Benefit survey. The Biennial survey is important in providing OPRA information necessary to our advocacy efforts. We would like to see increased participation in next year's survey and will be conducting a webinar prior to sending, outlining tips and tricks for completing efficiently. Statewide ISP: The workgroup tasked with creating the single statewide plan and assessment met this week on Wednesday, Nov. 20. The meeting focused on how to streamline the assessment, which began the meeting at 77 pages. A sub-committee was formed to condense, standardize and format the assessment so that it may be ready to pilot early in 2020. Meeting minutes will be posted next week. Legislative Meetings: This week Pete and Christine met with Senator Hackett and Representative Lipps, as well as staff from Senator Hottinger's office. Christine and OPRA's contract lobbyists also had the opportunity to attend a fundraiser for Speaker of the House Larry Householder. Many of the conversations centered around the 'great start' of last year's HPC rate increase, acknowledging the work still needing to be done to ensure a stable, quality service system, including much-needed rate structure redesign and increase in adult day array services. DSP Ohio: We are still actively monitoring the data we are getting through DSP Ohio. Since the launch of the media campaign in September, over 1,300 people have submitted their information to providers through the site, and we have seen traffic to the site in every county in the state. Wage Verification: This week's wage verification resulted in a potential path forward for how providers demonstrate that the rate increase is utilized towards direct staff wages and benefits.
