At the start of their daily press briefing, Governor DeWine praised the work being done by Direct Support Professionals throughout Ohio. Dr. Amy Acton went on to confirm 67 cases of coronavirus in Ohio and announced the postponement of elective surgeries. #### **Day and Vocational Services**

#### **DODD Suspends Assessments for ICFs**

Per DODD memo; "As the Ohio Department of Developmental Disabilities (DODD) responds to coronavirus (COVID-19), the department has suspended Ohio Developmental Disabilities Profile (ODDP) assessments for intermediate care facilities (ICFs) until further notice. If an ICF is unable to certify due to a person missing an assessment, DODD will complete the certification on behalf of the ICF, excluding the person missing an ODDP assessment." # ODJFS Provides Common Number to Speed Processing of COVID-19-Related <u>Unemployment Benefits</u>

Earlier today, ODJFS released guidance for processing for employees who lose their employment as a result of the pandemic. Per the announcement "The Ohio Department of Job and Family Services (ODJFS) is instructing Ohio employers planning layoffs or shutdowns as a result the coronavirus (COVID-19) pandemic to share the following mass lay-off number with their employees to speed the processing of unemployment benefits: 2000180.
