### **Ohio Submits Emergency Waiver Applications**

Earlier this week, Governor Mike DeWine announced that Ohio submitted emergency 1135 and Appendix K waiver applications to CMS. These waiver requests codified many of the regulatory relaxations put into place by DODD since early March. The relief application did not, however, contain any of the financial relief proposals for disability providers as submitted to the Ohio Dept of Medicaid by DODD. OPRA is still pursuing strategies to ensure necessary funding through the crisis, including signing on to a coalition letter to Governor DeWine sent last night.

### Governor DeWine Signals Phased-in 'Re-Opening'

During Thursday's press briefing, Governor DeWine announced that Ohio would begin developing plans focusing on 'reopening' the economy gradually, beginning with businesses that are able to demonstrate safe social distancing practices. Due to Ohio hospitals currently being undercapacity, DeWine signaled that elective surgeries would be opened up again next month. Throughout the week OPRA held committee calls and listening sessions with many of our committees including the residential waiver, ICF, Day Service, Employment Service and Facility-free workgroup. We gained valuable feedback from the membership on how all of you are working through the crisis and what lessons have been learned for when the crisis subsides. The day and employment services committee provided updates on innovative ways day service are being delivered, including one member who is doing 'virtual vacations' with the people they are supporting.

#### **OPRA Distributes Donated PPE to Members**

Following last weekend's article in the Columbus Dispatch, OPRA received large mask donations that we were able to distribute to members throughout the state. ### **ODH Orders Notification Requirement**

The Ohio Department of Health order\_issued April 15 requires that all DODD licensed facilities give notice to residents and guardians within 24 hours of the first time they have a positive or probable case of COVID-19 within the facility.

### COVID-19 MUI Data from Ohio's DD System:

Scott Phillips of DODD shared with us the latest data as it concerns the impact of Covid-19 on people supported in Ohio's disability service system.

"In Ohio, we have had 5 deaths reported within our service delivery system. (Lucas County-2, Miami-1, Hamilton -1 and Franklin -1).

102 people have had Unanticipated Hospitalization MUI's reported and have been tested for COVID-19. (Of the 102 people tested 68 were negative, 30 were positive and 4 are pending).

67% Male and 33% female.

The average age is 55.....With the oldest person 79 and the youngest 12.

31 of the 88 counties have reported hospitalizations involving COVID-19.

Cuyahoga County leads our MUI reports with 14 people hospitalized, followed by Hamilton 11 and Franklin 9. These are overall reports of people being tested not positive results. Positive results (30) have been reported in 6 counties (Belmont, Cuyahoga, Franklin, Hamilton, Lucas, and Miami)

NODC is our only Developmental Center with positive cases at this time.
