Senator Brown Signs Phase 4 Coalition Letter

Earlier this week, Senator Sherrod Brown, along with several Democratic senators signed a letter to congressional leaders, outlining provisions to support people with disabilities they hope to see included in upcoming COVID-19 legislation. The requested provisions in the letter include;

- -A 12% increase in FMAP to support Medicaid services for people with developmental disabilities.
- -A \$50 Billion investment into HCBS services.
- -Assurance of civil rights for people with DD in health/hospital care.
- -Additional clarity that stimulus payments do not impact benefits.
- -Methods to ensure people with disabilities have access to food and medication.
- -The enactment of the Defense Production Act to create more PPE.

DOL Releases Guidance on Reimbursing Employers

Earlier this week, the US Department of Labor released guidance for reimbursing or self-insuring employers, which was described by the National Council of Non-Profits as "breathtakingly cruel" as it guided states to begin billing those non-profits at 100% of paid benefits. We know this is a major issue for many members and is an advocacy priority for us as we look to additional relief for reimbursing non-profits in phase 4 federal legislation. Guidance on Day Array Expected Today

As the economy begins to reopen, we know there are many people looking to begin day services again, and that there has been conflicting guidance coming from county boards on authorizing those services. DODD is developing guidance to clearly outline requirements to safely provide services and ensure continuity of approach throughout the state. The previous requirement of '10 people or less' remains in effect. A small workgroup is also being formed to discuss how Ohio's day array providers will continue to reopen and serve more people in healthy, safe environments.

3 of 6 County Board Levies Passed

On Tuesday's primary election, Ohio voters approved board levies in Hancock, Holmes and Scioto county. Levies in Lawrence, Marion and Morrow counties failed to get the voter support needed.

COVID-19 MUI Data from Ohio's DD System:

Scott Phillips of DODD shared with us the latest data as it concerns the impact of Covid-19 on people supported in Ohio's disability service system.

"Providing updated MUI COVID-19 data. In Ohio, we have had 10 deaths reported within our service delivery system. (Lucas County-3, Miami-1, Hamilton -1, Franklin -1 Wayne-1, and NODC -3).

171 people have had Unanticipated Hospitalization MUI's reported and have been tested for COVID-19. (Of the 171 people tested 121 were negative, 48 were positive and 2 are pending).

61% Male and 39% female.

The average age is 55.....With the oldest person 88 and the youngest 2.

44 of the 88 counties have reported hospitalizations involving COVID-19.

Cuyahoga County leads our MUI reports with 25 people hospitalized, followed by Lucas County 15 and Franklin 15. These are overall reports of people being tested.... not positive results. Positive results (48) have been reported in 7 counties (Belmont, Cuyahoga, Franklin, Hamilton, Lucas, Miami, Ottawa, Perry, Portage and Wayne.)

NODC is our only Developmental Center with positive cases at this time.
