Blue Print for Adult Services: On Tuesday July 7, the Blue Print for Adult and Employment service workgroup met for the first time since its opening meeting in January. The 2-hour, virtual meeting was primarily a recap of the summary of the group's work in January and establishment of time-frames to move forward. The charge of this group is to set forth recommendations to Director Davis for improvements that will help stabilize and align the day array support sector. Given the complications of the COVID crisis, the work being done in this group will be more important than ever, establishing rules, rates and structure that will support person-centered, quality services while our system is still reeling and recovering from the COVID Crisis.



HHS/HRSA Webinar: On Wednesday, the HHS and HRSA hosted a joint webinar addressing several participant-submitted questions about the Provider Relief Fund portal for Medicaid and CHIP providers. While there was not too much new information, the application date was confirmed to be July 20, clearing up previous conflicting dates. HHS also released a new fact sheet, outlining key application points, eligibility factors and attestation process, which can be found here.

Health Advisory Alert System: Last week Governor Mike DeWine introduced a new county, color-coded map to indicate areas where COVID-19 cases are increasing. People in level 3 counties will be required to wear face coverings when in public areas. As of Thursday the following counties have been designated a level 3; Butler, Clermont, Cuyahoga, Fairfield, Franklin, Hamilton, Lorain, Montgomery, Pickaway, Summit, Trumbull, and Wood. 

#### COVID-19 MUI Updates July 10, 2020

The Department provides the following MUI updates based on COVID-19 related unanticipated hospitalizations and/or deaths. This data is not all inclusive and is updated daily from the Incident Tracking System. It does not include information about people who are suspected of having COVID-19 but not hospitalized, those who tested positive but not hospitalized, people living with their families and those who are hospitalized when there is no provider present at time of hospitalization and COVID testing.

#### Summary:

- In Ohio, we have had 21 people die of COVID-19.
- The average age of the person who died was 60 years old.
- A total of 11 counties and 1 DC have reported COVID-19 deaths. The 21 deaths were reported in Belmont (1), Clark (1), Cuyahoga (1) Franklin (3), Hamilton (2), Lucas (4), Mahoning (1), Miami (1), NODC (4), Perry (1), Warren (1) and Wayne (1).



- A total of 449 COVID-19 reportable MUIs were filed as 6 individuals were never hospitalized but it was later determined their cause of death was COVID-19.
- A breakdown of testing results of the 449 people follows:
  - 312 people tested negative
  - 6 people have pending tests results
  - 131 people tested positive.
- Males accounted for 62% of those tested and females 38%.
- Ages of people tested ranged from 2 to 88 years. The average age was 54 years.
- 59 counties and 3 developmental centers reported COVID related MUIs.
- Cuyahoga had the most people hospitalized and tested with 64 followed by Franklin with 62.
   Cuyahoga county had the most people who have tested positive with 30 followed by Franklin with 21.
- Twenty-two counties and 1 DC have reported individuals with positive results (131). Those
  include Belmont, Butler, Carroll, Clark, Cuyahoga, Darke, Franklin, Hamilton, Lake, Licking,
  Lucas, Mahoning, Miami, Montgomery, Ottawa, Perry, Pickaway, Portage, Scioto, Summit,
  Warren, Wayne and Northwest Ohio DC).
