<u>Speaker of The House:</u> Following a unanimous vote earlier this week to oust indicted Representative Larry Householder from the Speaker position, Ohio's House of Representatives elected Rep. Bob Cupp to take that mantle. Cupp, who has served the Lima-area district since 2015 previously served as a Justice on Ohio's Supreme Court. Cupp was approved by the house in a 55-38 vote, following a very close GOP vote between Cupp and Rep. Jim Butler. We look forward to working with Speaker Cupp on our priorities heading into the next budget cycle. <u>To read more, click here.</u>

<u>Simplification and System Reform:</u> Following robust discussion at last Monday's Policy Committee meeting, OPRA's board of directors met this week to to review and approve several 'guiding principles' that will guide OPRA's advocacy and approach to simplification and reform. The principles, which are being finalized following board recommendations, center on positive relationships, trust for providers, fair reimbursement and the importance of all the different types of services provided by OPRA members and DD providers. OPRA recommendations on state policy simplification will be organized and guided by these principles. Once finalized, we will be sharing the principles as well as several actions steps and opportunities for reform with members.

<u>Phase 4 Federal Legislation:</u> Earlier this week, The US Senate released their version of the HEROES act called the HEALS Act. Since the bill's introduction, we have seen very little positive movement on reconciling the bills to get a comprehensive relief bill passed. <u>Click here to read an analysis of the difference between the two bills.</u>

The HEALS Act did not include the HEROES Act provisions to support state's Medicaid program or states' HCBS waiver programs. In response, <u>Senator Sherrod Brown signed onto this letter</u> to Senate and House of Representatives to strongly encourage negotiations to include the Medicaid and HCBS waiver funding provisions. The provisions in this letter directly reflect the advocacy positions we have asked Senators Brown and Portman to support, showing the importance of our advocacy on this pending legislation.

Statewide COVID-19 MUI Data: Scott Phillips, Assistant Deputy Director of DODD's MUI Unit, shared with us the latest data report on how COVID-19 is impacting people with disabilities supported by our system

#### As of July 31, 2020:

- There were 568 people hospitalized and tested for COVID-19, which resulted in a MUI filing. This is an increase of 51 new hospitalizations with COVID testing since the last report, which was issued on Friday, July 24, 2020.
- A total of 574 COVID-19 reportable MUIs were filed as 6 individuals were never hospitalized but it was later determined their cause of death was COVID-19.

- There were 63 counties and 3 developmental centers with COVID related MUIs. Cuyahoga had the most people hospitalized and tested with 82 followed by Franklin with 70. Cuyahoga county had the most people who have tested positive with 38 followed by Franklin with 24. A breakdown of testing results of the 574 people follows:

  - 377 (66%) people tested negative
  - 12 (2%) people have pending tests results
  - 185 (32%) people tested positive.

Twenty additional people tested positive since July 24, 2020.

#### **Demographics:**

- Males accounted for 60% of those tested and females 40%.
- Ages of people tested ranged from 2 to 91 years. The average age was 54 years. The most common age was 64 years.
- The breakdown of people tested by race include:
  - Black or African American-16% (.31 positive testing rate)
  - Other Race -2% (.09 positive testing rate)
  - Unknown-5% (.05 positive testing rate)
  - White/Caucasian 77% (.18 positive testing rate)

### COVID-19 Deaths:

- Twenty-four (4.5%) people died of COVID-19 of the 574 reported.
  The mortality rate of those passing from COVID-19 (24) and the total people served (98,396) is .024.
- The average age of the person who died was 60 years old.

  A total of 12 counties and 1 DC have reported COVID-19 deaths. The 24 deaths were reported in Belmont (1), Clark (1), Cuyahoga (1) Franklin (3), Hamilton (2), Lucas (4), Mahoning (2), Miami (1), NODC (4), Ottawa (2) Perry (1), Warren (1) and Wayne (1).

  Lucas county and NODC have the highest number of deaths reported with 4 each.
