HHS Provider Relief: HHS has again delayed the deadline for applying for the Provider Relief Fund. The new deadline is now September 13th. The deadline also includes providers who received a small amount of money through the Medicare release of funds and are hoping to make up the difference of what they could have received under the Medicaid release. OSHA Resource/Requirement Guide: Over the last several weeks we have discussed the requirements from the Occupational Safety and Health Administration (OSHA) for keeping staff safe when working with people who have tested positive for COVID. <u>Appendix K Billing Deadline:</u> Ohio has requested relief funding for HPC, OSOC and shared living providers through an Appendix K application with CMS. These payments will be made to providers based on a percentage of billing claims from March-July 2020. Pending CMS approval, DODD is hoping to push these funds out quickly, <u>asking providers to complete July billing by next 12 PM Wednesday 9/2</u> to finalize payment calculation for maximum provider disbursement.

<u>DODD COVID-19 MUI Updates:</u> This week, Scott Phillips provided us with another update on the impact of COVID-19 on people in the Ohio DD service system, based on reported MUIs.

As of August 28, 2020:

- · There were 666 people hospitalized and tested for COVID-19, which resulted in a MUI filing. This is an increase of 25 since the 8/22/2020 report.
- · A total of 677 COVID-19 reportable MUIs were filed as 11 individuals were never hospitalized but it was later determined their cause of death was COVID-19.
- 231 people served have tested positive for COVID-19 and been hospitalized. This is an increase of 12 positives since the 8/22 report.
- 41 people served have passed away who have tested positive for COVID-19. There is an increase of 5 confirmed deaths (confirmation by death certificate/ODH Vital Statistics) since the 8/22 report.

- There were 65 counties and 3 developmental centers with COVID related MUIs.
- · Cuyahoga had the most people hospitalized and tested with 100 followed by Franklin with 90.
- · Cuyahoga county had the most people who tested positive with 47 followed by Franklin with 33.

Demographics

- Males accounted for 60% of those tested and females 40%.
- Ages of people tested ranged from 2 to 91 years. The average age was 54 years. The most common age was 61 years.
- · The breakdown of people tested by race include:
 - · Black or African American-16% (41% positive testing rate)
 - Other Race -2% (60% positive testing rate)
 - Unknown-5% (50% positive testing rate)
 - · White/Caucasian 76% (31% positive testing rate)

COVID-19 Deaths:

- · Forty-one (6%) people died of COVID-19 of the 677 reported. This is an increase of 5 more confirmed deaths since last week's report.
- · The mortality rate of those passing from COVID-19 (41) and the total people served (94,980) is .043.
- The average age of the person who died was 64 years old.
- · A total of 20 counties and 1 DC have reported COVID-19 deaths.
- A breakdown of deaths by county boards and developmental centers follows:
