<u>Federal Relief Legislation-</u> Yesterday, Senator McConnell and Senate Republicans introduced a \$300 Billion COVID Relief bill designated as a 'skinny relief' package. The bill, which had the support of 52 GOP Senators, did not advance after a Democratic fillibuster. The failed legislation included a continuance of additional \$300 weekly unemployment benefit, as well as civil liability provisions, but did not include any direct relief for Medicaid service providers. Even though the outlook for further Federal relief prior to the election is looking slimmer by the day, OPRA will continue to advocate for our relief priorities, many of which were included in the HEROES act, passed by the house back in May. <u>To learn more about the legislation, click here.</u>

<u>ICF Intensive Behavior Add-on:</u> The application period is now open for the intensive behavior support add-on rate for ICF providers who can support youth ages 10-17 with dual diagnoses in mental health and developmental disabilities. The process, which includes an application for the provider and then individual-specific application for the add-on will be open through November 2 for interested providers. This afternoon both the work services and quality/governance committees will meet to work on system scenarios and further develop policy recommendations. We will continue to advance OPRA's principles for system reform through this workgroup, with recommendations that help simplify the system, provide more resources for the full spectrum of adult supports and enhance relationships between front-line staff and the people you support.
