**Policy Committee:** OPRA's Policy Committee met on Monday to continue developing advocacy and policy priorities based on OPRA's guiding principles for system reform. Following a presentation of our September AIR (Advocacy, Information, Resources) report, the committee, Chaired by Diane Beastron and Scott DeLong, began in-depth discussions on the workforce crisis, and the several approaches needed to improve the crisis, which has been greatly exacerbated by COVID-19. OPRA has developed a 4-quadrant approach to the crisis, developing solutions to recruitment, culture/retention, wages and system barriers. The Policy committee will continue to focus on system reform priorities, with workforce issues being the major focus as we move into next year's state budget cycle. **Day & Employment Service Committees:** On Thursday, OPRA held another joint meeting of our Day & Employment service committees. We want to thank everyone who attended and participated in the meeting where the committee discussed topics such as best practices for virtual services, the future of STEP services, and strategies for providing day services for individuals residing in ICFs. The committee also discussed the several proposals developed in the Blueprint workgroup, which meets again next Friday, October 23rd. Additionally, the committee developed further recommendations for day services in 2021, after the statewide Acuity C payment structure is discontinued. **MRC Changes:** In a memo sent to the field earlier this week, DODD indicated that the MRC (Monthly rate calculator) would no longer be automatically adjusting up the daily billing unit when a provider exceeds the 103% service threshold. This practice, which has been in effect since March, allowed flexibility during a time when it was likely people would be needing additional residential supports due to lock-down and other factors. **Appendix K:** Talks have begun among our state agency partners regarding Ohio's re-application for Appendix K relief and rule relaxations. The current application, which allows states to apply for emergency changes to their Medicaid programs, expires at the end of January. This application will be necessary to maintain many of the current Covid-related rule relaxations, as well as allowing for STEP-style virtual and in-home day services. This is also an opportunity to pursue further fiscal relief, especially in the case of an outbreak or resurgence of the virus. We will keep members updated on the application process as it moves forward.
