Budget Coalition: We met with our budget coalition of OACB, OHCA and the Arc earlier this week to continue our discussions on advocacy priorities and strategies as the budget process moves forward. Though there was not much movement on the budget front this week, we began discussions with our partners around the enhanced FMAP (Federal Medical Assistance Percentage), a provision of the American Rescue Plan. There are still many uncertainties around how the 10% FMAP bump can be applied to state Medicaid funding, and the OPRA team is working on several scenarios and strategies for how the increase can potentially be used. The House leadership is currently in process of organizing all of the amendments and reaching out to house members to gauge amendment priorities. We have heard that a Sub-bill may be introduced in early April, but at this point timelines are still unclear. With Spring Break around the corner, this could be a great time to reach out to your local legislator or potentially schedule a visit to your agency. Adult Day Revised Order: Yesterday, Director McCloud of ODH signed an updated version of the order regarding adult day group sizes. The previous version had a bullet in the final section (9) saying anyone who had been in potential contact with a positive case should quarantine for 14 days, which seemed inconsistent with previous orders and current guidance from CDC and ODH. This new, revised order, which went into effect yesterday, instead directs agencies to contact their health dept. and work with them on next steps, but does not outline the need for a 14-day quarantine for someone who was potentially exposed. <u>Blueprint:</u> The Blueprint workgroup has been on pause since October of 2020, but will regroup for the first time since the fall next week on March 25th. We have already provided feedback to the blueprint group through several surveys DODD set up to gather comments. In addition, we have made a request to DODD to fast-track 3 Blueprint items to hopefully coincide with any policy changes resulting from this budget cycle. Those items are the long-term continuance of STEP-style services, and rate adjustments on both group and individual employment. We look forward to advancing those priorities in next week's meeting. <u>Surveys Resuming</u>: As licensure and certification surveys begin to resume, as we have mentioned on our Friday calls, make sure you have your emergency preparedness and infection control policies/procedures updated and that your staff know what those policies/procedures are. <u>Awaiting Visitation Guidance:</u> We continue to see trend-lines for Covid moving downward. Long term care facilities reported 70 new cases this week compared to 157 the previous week, vs at the peak in December when LTCF's reported 2,832 new weekly cases. DODD is still working on updated guidance regarding visitation, attempting to align with <u>ever-changing guidance from CMS</u>. For right now, they continue to encourage the use of the Risk/Benefit Guide if someone is going for a visit – and to make sure that vaccinations or lack of vaccination is part of the team discussion.

As of March 19, 2021:

COVID-19 Testing Results for Reportable MUIs

808	24	1,004	1,836	

1,004 people served have tested positive for COVID-19 and been hospitalized. This is an increase of 5 additional positives since the 3/12 report. .

- 222 people served have passed away who have tested positive for COVID-19. There were 6 additional confirmed deaths since the 3/12 report. There were 1,750 people hospitalized and tested for COVID-19, which resulted in a MUI filing. This is an increase of 9 since the 3/12 report. .
- A total of 1,836 COVID-19 reportable MUIs were filed as 86 individuals were never hospitalized but it was later determined their cause of death was COVID-19.

Impacted Counties/Developmental Centers:

- There are 85 counties and 8 developmental centers with COVID related MUIs (CADC, CDC, GDC, TDC, MVDC, SODC, WDC and NODC).
- Franklin had the most people hospitalized and tested with 232 followed by Cuyahoga with 204.
- Franklin had the most people who tested positive at 118 people followed by Cuyahoga with 110.

Testing Demographics:

- Males accounted for 60.19% of those tested and females 39.81%.
- Ages of people tested ranged from 1 to 95 years. The average age was 55 years. The most common ages are 59, 61, and 63 years. •
- The breakdown of people tested by race is:
- Black or African American-15% (56% positive testing rate) •
- Other Race -2% (55% positive testing rate) •
- Unknown-5% (49% positive testing rate)
- White/Caucasian 78% (55% positive testing rate) •

COVID-19 Deaths:

- The mortality rate of those passing from COVID-19 (222) and the total people served (94,890) is 0.23%.
- The ages of those who passed away range from 4-95 years of age.
- The average age of the person who died was 61 years old.
- A total of 53 counties and 3 DCs have reported COVID-19 deaths.
