State Budget: The state budget process came to a close on Wednesday evening as Governor DeWine signed HB 110 into law. Following the conference committee, our initiatives, including the 2% yearly increases for waiver services and our ICF increases, remained in the budget. Governor DeWine wound up vetoing the bill language regarding our increased funding, but kept the appropriation, in order to give DODD more flexibility in how the rate increase could be implemented. The vetoed language opens the door to the possibility of 'upfronting' the full rate increase, leading to a 4% rate increase on 1/1/22, which Director Davis is considering and we are supportive of. The OPRA team has so many people to thank for the partnership, collaboration and support through the budget cycle. Most importantly we want to thank you, the OPRA community, for your support and advocacy over the last several months. We are beyond grateful to you all and our partners in the legislature for delivering these much-needed increases. <u>Click here to read more about the final version of HB 110</u>. <u>Regional Response Team:</u> Last night, DODD published guidance on a process they are calling the 'Regional Residential Crisis Support Plan'. The plan was developed and shared by DODD in preparation for the upcoming holiday weekend in an attempt to establish a process of support in emergency staffing situations. The process advises that providers first contact their county board liaison (established at start of pandemic), then if no resolution is found, the DODD regional team is contacted, eventually escalating to the 'DODD Strike Team'. While some of the process is unclear, we appreciate DODD's efforts to create a consistent response plan. <u>EFMAP/Acuity:</u> We learned recently that the Ohio Department of Medicaid has filed for a 30 day extension to submit their plan for how the state will utilize the enhanced FMAP allowed by the American Rescue Plan. We also learned that DODD has a call with CMS scheduled soon to discuss how the EFMAP impacts the enhanced acuity rates currently in place for ADS/Voc Hab. As we have discussed on previous calls, guidance from CMS on 'supplanting funds' may require the enhanced rate to be in place through March 2022, although the county boards have committed to 9/1/21 as the date they will fund the rate through. We hope to have clarity on both of these pieces in the coming weeks so providers are able to plan for any upcoming rate changes.

Inclusive Employer Award: Soon after he sworn into office, Governor DeWine signed a proclamation making Ohio a 'Disability Inclusion State and Model Employer of People with Disabilities''. As part of that effort, his office has launched the 'Inclusive Employer Award', to be presented during National Disability Employment Awareness Month in October.
