ARP/EFMAP: Earlier this week DODD sent an announcement that the Ohio Department of Medicaid had opened a stakeholder portal for input on how Ohio should utilize funding appropriated through the American Rescue Plan. Through the ARP, states can access an additional 10% in Federal matching funds for services and initiatives that 'expand or enhance the HCBS program'. The portal/survey contains in-depth questions about proposal ideas and the funding necessary to support those initiatives. We will be working with our partners from the WCTF and workforce coalition to submit a unified proposal to provide immediate financial relief for providers to help address the staffing crisis in addition to the proposal ideas shared with DODD months ago. <u>Delta Variant:</u> We are keeping a close eye on local, state and national trends regarding the spread of the Delta variant as well as the different policies being instituted around masking, distancing and vaccination on all levels. Due to a number of factors, we do not expect to see much in the way of additional guidance or mandates from the state/DODD as it pertains specifically to DD services. <u>An indoor mask advisory was issued yesterday in Franklin county</u> in response to the growing case numbers. We still believe the <u>OSHA ETS protocols</u> apply to most residential service providers and can be followed to help prevent infection/spread. We know members are doing everything they can to best ensure health and safety amidst the workforce crisis. Please reach out to Rachel with any questions about current guidance/requirements.

<u>OOD Provider Qualifications Rule:</u> On Monday, OOD released their updated version of the 'Provider Qualifications' rule, after reaction to feedback submitted by OPRA weeks back. As mentioned on the call last week, many of our points of feedback and suggestions were adopted into the new rule draft. We were very pleased to see such responsive actions from OOD to this proposed rule, and we believe much of that is owed to the relationships built and the advocacy work done through the Employment Service Committee. Thanks again to everyone who was a part of submitting feedback and developing advocacy stances on this rule. Please contact Scott with any questions.

<u>ICF Rates:</u> In this week's Memo Monday, DODD released the final ICF rates for fiscal year 2022, <u>which can be viewed here.</u> According to the memo "The full rate packages are not available due to a system error". The rates for FY22 were calculated based on a 2% increase to the rate in place on June 30, 2021 for all facilities. Please reach out to Rachel with any questions.
