Hot Spots: One key initiative proposed by OPRA and developed through the Workforce Crisis Task Force was the identification of 'Hot Spot' counties, areas of the state hit most hard by the workforce crisis. A team of representatives including Pete from OPRA, as well as reps from OACB and DODD began visits this week, meeting with providers, county board staff and families in 4 of the 27 identified counties. The purpose of these visits is to listen and understand how the staffing shortages are impacting people supported by and providing services and to hear perspectives on how the crisis could be addressed. These visits will continue over the next several weeks until all of the hot spot regions have been visited. Please contact <u>Pete</u> with any questions about the WCTF.

Vaccine Mandate: On Wednesday, President Biden announced that his administration will be mandating COVID vaccination for nursing home staff as a condition of participation in Medicaid/Medicare. The nursing home guidelines will be developed by CMS, who we continue to work with through our partners at ANCOR, as we monitor potential mandates for ICF staff. The mandate presents a staffing challenge to the nursing homes and we have great concern on what impact a potential mandate in our field could have on the crisis providers are already working through. We are hopeful that the high percentage of individuals served through ICFs who are vaccinated may lessen the need for such a mandate. We will continue to monitor the vaccine mandate developments closely and we remain in close contact with our Federal partners, ensuring all are aware of the potential impact such a mandate would have on our workforce. Acuity Return: Earlier this week DODD issued a communication that the enhanced acuity rates in effect for day & vocational services will return to their normal rates as of 9/1/21. This news comes after months of awaiting guidance from CMS as to whether the rate must stay in place until next year to ensure Ohio's ARPA funding. After CMS gave the state clearance that rates could change back to normal without jeopardizing the funding, DODD decided to move ahead with 9/1 date. We are incredibly dismayed and concerned about this change and how it was communicated. Please feel free to reach out to Scott with any questions or further feedback about the return to acuity billing.

ARPA Submission: After collaboration with our coalition partners, we submitted several proposals into ODM's stakeholder portal, identifying ways the enhanced federal funding through ARPA should be utilized. We submitted 2 joints proposals with our coalition partners, requesting \$100M in state matching funds saved through ARPA for lump-sum provider payments and an additional \$50M to support proposals developed through the WCTF. OPRA also independently submitted proposals supporting lump-sum payments for ICFs, retroactive funding for providers serving individuals assessed at Acuity C through the pandemic and funding for a specialized rate for DSPs with longevity and experience who are providing intensive or specialized services. #### As of August 20, 2021:

- 1,084 people served have tested positive for COVID-19 and been hospitalized. This is an increase of 9 additional positives since the 8/13 report.
  241 people served have passed away who have tested positive for COVID-19. There was 1 additional confirmed death since the 8/13 report.

  There were 1,943 people hospitalized and tested for COVID-19, which resulted in a MUI filing. This is an increase of 14 since the 8/13 report.

  A total of 2,037 COVID-19 reportable MUIs were filed as 94 individuals were never hospitalized but it was later determined their cause of death was COVID-19.

#### Impacted Counties/Developmental Centers:

- There are 85 counties and 8 developmental centers with COVID related MUIs (CADC, CDC, GDC, TDC, MVDC, SODC, WDC and NODC).
- Franklin had the most people hospitalized and tested with 243 followed by Cuyahoga with 217. Franklin and Cuyahoga had the most people tested positive with 122.

#### **Testing Demographics:**

- Males accounted for 60.28% of those tested and females 39.72%.
- Ages of people tested ranged from 1 to 95 years. The average age was 54 years. The most common ages are 59.
- The breakdown of people tested by race is:
- Black or African American-15% (55% positive testing rate)
- Other Race -2% (54% positive testing rate)
- Unknown-5% (47% positive testing rate)
- White/Caucasian 78% (53% positive testing rate)

#### COVID-19 Deaths:

- The mortality rate of those passing from COVID-19 (241) and the total people served (94,890) is 0.253%. The ages of those who died range from 4-95 years of age.

  The average age of the person who died was 62 years old.

  A total of 56 counties and 3 DCs (CDC, NODC, TDC) have reported COVID-19 deaths.

- Franklin has the most confirmed COVID deaths with 22.

We are continuing to see slight increases in potential hospitalizations and positive tests. Thankfully, the hospitalizations and symptoms associated have not been as significant for those having received the vaccine but we remain concerned and will still follow closely

The Department provides the following weekly MUI updates based on COVID-19 related unanticipated hospitalizations and/or deaths entered into the Incident Tracking System. This data is not all inclusive. It does not include information about people who were suspected of having COVID-19 but not hospitalized, those who tested positive but were not hospitalized, people living with their families who were hospitalized when there was no provider present at time of hospitalization and COVID tested.
