Legislator Meetings: OPRA members and staff have participated in recent meetings/visits organized with OACB to continue communication about the impact of the workforce crisis with members of Ohio's legislature. We are grateful to all of our members who have so eloquently shared their experience of the challenges of providing services during the pandemic and workforce shortage with their state representatives. We appreciate the partnership of OACB in continuing to build and further develop these legislative relationships. Those relationships will be all the more important as we seek legislative approval for the release of the funding from Ohio's ARPA spending proposal, once it is approved by CMS. Discussions with the administration and legislators have included the need for relief funding for ICFs, as well as the HCBS relief funding appropriated by ARPA, which the plan submitted by ODM indicates will be made available by March of 2022. We have follow-up meetings next week to continue discussions on ARPA and ICF relief funding and how to ensure it gets to providers as quickly as possible.

MRC: We met with DODD and system partners stakeholders to continue discussions on how to move forward on the several issues with the Monthly Rate Calculator(MRC) we've discussed over the past few months. This team is looking at all options in how to address the challenges in MRC and simplify billing in general. Options include expanding the MRC '6% window', to discussions of a whole new approach/system more reflective of the current environment. The one thing that all partners seem to agree on is the need for simplified billing, so this group has a real opportunity to promote change that leads to simplification.

<u>Technology First Taskforce:</u> Earlier this week, DODD led the kick-off meeting of the 'Technology First Task Force', consisting of representatives from the Department of Aging, Mental Health, Education, Transportation, Medicaid, OOD and InnovateOhio. Since serving on the Tech First Advisory Committee over the summer, we were asked to be a part of presenting the recommendations from that committee to this multi-agency task force, whose goal will be to operationalize those recommendations. <u>Click here to read the Tech First Advisory Committee recommendations.</u>

On-site/On-call (OSOC): The OSOC assessment tool is about ready to go live. You can access the PDF tool on DODD's website by clicking here. It will be going for testing 11/2-11/12 and will be ready for use on 11/18. This process was a good example of different stakeholders working together to try and make a complicated system easier to utilize – which is what we want to do with MRC and simplifying billing. The Department provides the following weekly MUI updates based on COVID-19 related unanticipated hospitalizations and/or deaths entered into the Incident Tracking System. This data is not all inclusive. It does not include information about people who were suspected of having COVID-19 but not hospitalized, those who tested positive but were not hospitalized, people living with their families who were hospitalized when there was no provider present at time of hospitalization and COVID tested. #### As of October 29, 2021:

- 1,230 people served have tested positive for COVID-19 and been hospitalized. There were 8 additional positives since the 10/22 report.
- There were 10 additional hospitalizations since the 10/22 report. This is a total of 2,155 people hospitalized and tested for COVID-19.
- A total of 2,261 COVID-19 reportable MUIs have been filed as 106 individuals were never hospitalized but COVID-19 was suspected or later determined as their cause of death.
- · 265 people served have passed away who have tested positive for COVID-19. There were 4 additional confirmed deaths since the 10/22 report.

#### Impacted Counties/Developmental Centers:

- There are 86 counties and 8 developmental centers with COVID related MUIs (CADC, CDC, GDC, TDC, MVDC, SODC, WDC and NODC).
- Franklin had the most people hospitalized and tested with 251 followed by Cuyahoga with 231.
- Cuyahoga had the most people tested positive with 132 and Franklin had 129.

#### Testing Demographics:

- Males accounted for 60.11% of those tested and females 39.89%.
- Ages of people tested ranged from 1 to 95 years. The average age was 54 years. The most common ages are 61.
- The breakdown of people tested by race is:
- Black or African American-15% (56% positive testing rate)
- Other Race -2% (56% positive testing rate)
- Unknown-5% (50% positive testing rate)
- White/Caucasian 78% (54% positive testing rate)

#### COVID-19 Deaths:

- The mortality rate of those passing from COVID-19 (265) and the total people served (98,956) is 0.267%.
- · The ages of those who died range from 4-95 years of age
- · The average age of the person who died was 61 years old.
- · A total of 56 counties and 3 DCs (CDC, NODC, TDC) have reported COVID-19 deaths.
- · Franklin has the most confirmed COVID deaths with 23.


