<u>Waiver Workgroup:</u> DODD's workgroup, led by the Medicaid Division, met on Monday of this week to continue its work towards the waiver simplification effort intended to be effective on July 1st. This effort will simplify/combine the Level 1 and SELF waiver, along with introduce some new service options, including self-directed transportation. The workgroup has split into 4 sub-groups, focused on self-directed transportation, participant-directed goods and services, Level 1 and SELF waiver redesigns. Certain rules, such as the 'general requirements' and SELF waiver administration, will need to be updated to incorporate these changes further. Reach out to <u>Pete</u> with any questions or feedback.

Behavior Support: The behavior support rule is up for its 5-year review so we are preparing comments as its review/draft renewal moves forward. Just some initial takeaways, the new rule has a much better format, particularly for providers to follow. It lays out what needs to occur and when, as well as specific trainings and things the HRC committee is responsible for. And these were in the current rule, but the format and flow is better so that people aren't searching for all the things they need to do. There are some issues that we are looking at regarding chemical restraints as there is some language in there that we believe should be modified. The rule is up for public hearing next week so we plan on having some remarks prepared. Contact Rachel or Christine with any feedback.

<u>Self-Directed Transportation: DODD's</u> Self-Directed Transportation workgroup met on tuesday to continue work on the proposed service and rule. This service would essentially allow people to purchase transportation options such as Uber, Lyft, other public and commercial transportation not certified through Medicaid, or even pay friends, neighbors, family or coworkers for transportation for reimbursement. The rule is on track to be implemented on July 1st, which means the rule-making process will have to happen quickly. <u>The draft rule can be found here</u> and we would love any member feedback by Friday, February 18, if possible. <u>CMS Mandate Implement Dates:</u> The CMS Phase 1 implementation date of February 14th is approaching quickly. So if you have not begun preparations for implementation of the CMS IFR, you need to do so immediately. As a reminder, we did receive confirmation last week that day service providers who contract with ICF's are not included as part of the mandate. We of course are anxiously awaiting how surveyor's will begin surveying for this rule. We encourage any provider who participates in a survey in the next few months to make sure they give us a call to let us know what they say or how they survey your facility as we want to make sure we get any feedback, positive or negative, to CMS. <u>OPRA's CMS vaccine mandate IFR resource page can be found here.</u>

COVID-19 Testing Results for Reportable MUIs-February 4, 2022

- 1,545 people served have tested positive for COVID-19 and been hospitalized. There were 21 additional positives since the 1/27 report.
- There were 21 additional hospitalizations since the 1/27 report. This is a total of 2,483 people hospitalized and tested for COVID-19.
- A total of 2,638 COVID-19 reportable MUIs have been filed as 155 individuals were never hospitalized but COVID-19 was suspected or later determined as their cause of death.
- 339 people served have passed away who have tested positive for COVID-19. There were 8 additional confirmed deaths since the 1/27 report.

Impacted Counties/Developmental Centers:

- There are 86 counties and 8 developmental centers with COVID related MUIs (CADC, CDC, GDC, TDC, MVDC, SODC, WDC and NODC).
- Franklin had the most people hospitalized and tested with 264 followed by Cuyahoga with 253.
- Cuyahoga had the most people tested positive with 156 and Franklin had 141.

Testing Demographics:

- Males accounted for 59.36% of those tested and females 40.64%.
- Ages of people tested ranged from 1 to 95 years. The average age was 54 years. The most common ages are 62.
- The breakdown of people tested by race is:
- Black or African American-14% (56% positive testing rate)
- Other Race -2% (56% positive testing rate)
- Unknown-5% (52% positive testing rate)
- White/Caucasian 79% (56% positive testing rate)

COVID-19 Deaths:

- The mortality rate of those passing from COVID-19 (339) and the total people served (98,956) is 0.332%.
- The ages of those who died range from 4-95 years of age.
- The average age of the person who died was 60 years old
- A total of 67 counties and 4 DCs (CDC, MVDC, NODC, TDC) have reported COVID-19 deaths.
- Franklin has the most confirmed COVID deaths with 26.
