Insert Brief Product Highlights Here- ProvideTM is an application used to view all of the information collected through the AccelTraxTM work reporting systems. Field based employees can report their work via a telephonic system and/or a web based application. ProvideTM enables supervisors to manage all consumer and employee personal information, view work reported by employees in real-time, process notices of actions, and attach documents. Supervisors are also given the ability to plan and schedule work for employees based on consumer specific authorizations. An important feature of ProvideTM is the Work Report tool, which generates billing and payroll information based on the work that has been reported. The Accel ProvideTM system has a consumer area that manages consumer's authorization data, reported work, planned work and events, contacts, diagnosis, etc. The system also includes an employee section that manages employee work, schedules, attributes, HR items, notes etc. The end user with proper security can view all the work by consumer(s) or by roommate or by employee. Work activity collected via employee entry on the web or phone is immediately available to the managers. The system maintains a comprehensive history of all work from the time reported through payroll and billing. The system allows for share/group work activities to be reported including date worked, start time, stop time, number of and which consumers are served, type of service delivered, detailed programmatic information such as consumer goals and objectives, prompting, success/failure reasons etc. The web interface is typically customized per client. The client's employees are trained on how to enter time and notes on the web, as well as the phone. Use of the phone ensures that any employee can report work activity. The windows based interface for managers provides an easy to use system that can be set to user based lists for easy monitoring of case loads or employee lists. Managers can approve time on a per segment, per day, per employee, per period or bulk of any work done.
