ICF Payments: DODD announced last Friday that ICF relief payments were processed on March 21, 2022. Payment will be made based on bed count as of 3/1 and for providers in "good standing." ICF's should see the payments approximately 7 days after processing. In our discussions with the department, there will be no new reporting guidance or mechanism. However, since this is a Medicaid payment, providers will need to keep documentation on how they spend the money in the event of an audit from the auditor of state. Providers will need to ensure that they spend the money in ways that align with the emergency rule and HB 169. Click here to read the emergency rule authorizing the ICF payments.

<u>Wage Verification:</u> We are on the eve of mandatory wage verification for HPC provider agencies. This process is a result of the HPC rate increases from a couple biennium budgets ago, where an assurance to the legislature was made that the budget investments would go towards a statewide average wage for DSPs. The wage verification tool and process was piloted with a group of providers last year. The survey tool will go live on April 4 and must be completed by June 30, 2022. DODD is conducting two trainings and will be hosting office hours through June.

OSHA: OSHA is ramping up for a new permanent standard. We have been talking about this for the last couple months in the wake of the Supreme Court's decision to strike down the Vaccination ETS and the expiration of the Healthcare ETS. This week OSHA partially reopened the rule-making record and are seeking public comment on several issues related to the possible development of a permanent standard for healthcare and healthcare support workers. OSHA has stated that they are seeking comments in a number of areas. You can access the public comment portal by clicking here.

<u>Esther's Law:</u> Senate Bill 58, <u>known as 'Esther's Law' went into effect this week in Ohio.</u> This law allows the installation of cameras by families and guardians of residents of in certain long-term care settings. There has been some heavy reporting and attention on the law and we just want to make sure that members know that it does not apply to ICFs.

COVID-19 Testing Results for Reportable MUIs

1,112	1	1,593	2,706		

- 1,593 people served have tested positive for COVID-19 and been hospitalized. There were 5 additional positives since the 3/18 report.
- There were 5 additional hospitalizations since the 3/18 report. This is a total of 2,536 people hospitalized and tested for COVID-19.
- A total of 2,706 COVID-19 reportable MUIs have been filed as 170 individuals were never hospitalized but COVID-19 was suspected or later determined as their cause of death.
- 372 people served have passed away who have tested positive for COVID-19. There were 3 additional confirmed deaths since the 3/18 report.

Impacted Counties/Developmental Centers:

- There are 87 counties and 8 developmental centers with COVID related MUIs (CADC, CDC, GDC, TDC, MVDC, SODC, WDC and NODC).
- Franklin had the most people hospitalized and tested with 267 followed by Cuyahoga with 257.
- Cuyahoga had the most people tested positive with 160 and Franklin had 145.

Testing Demographics:

- Males accounted for 59.27% of those tested and females 40.73%.
- Ages of people tested ranged from 1 to 95 years. The average age was 54 years. The most common ages are 62.
- The breakdown of people tested by race is:
 - Black or African American-14% (60% positive testing rate)
 - Other Race -2% (56% positive testing rate)
 - Unknown-5% (52% positive testing rate)
 - White/Caucasian 79% (59% positive testing rate)

COVID-19 Deaths:

- The mortality rate of those passing from COVID-19 (372) and the total people served (98,956) is 0.375%.
- The ages of those who died range from 4-95 years of age.
- The average age of the person who died was 60 years old.
 A total of 70 counties and 4 DCs (CDC, MVDC, NODC, TDC) have reported COVID-19 deaths.
- Franklin has the most confirmed COVID deaths with 28.
