Adult Day & Vocational Guidance: In this week's Memo Monday, DODD published 2 new guidance pages for ADS and Voc Hab services. The new [Adult Day Support guidance page](#) contains information on how to authorize, provide and bill for the service. We are requesting that DODD includes guidance regarding the ability to 'drop in' to center-based services while providing community services at a daily billing rate. [The Vocational Habilitation page](#) is a little more curious as it doesn't contain any of the same type of information as the ADS page, instead focusing on federal definitions of pre-vocational services and Ohio's efforts towards community employment. Given the indefinite delay of the 'BEST' service, we believe this guidance is intended ensure that Voc Hab services are provided in alignment with CMS's definition of pre-vocational services, as outlined in the guidance page. Level of Care: Earlier this week, DODD put out a notice that beginning on June 27th, ICF Level of Care system users will have access that allows you to assign up to two people the ability to receive emails for certain LOC functions. We know this at times has been frustrating from a communications standpoint and only having the ability to have one person listed. This function will be available for ICF users who have the ICF CEO role within the Level of Care application. Hopefully this can help with some of the issues that can result when you only have 1 person being able to be listed in there. Retention Program: We are still awaiting approval from CMS on the 6.5% retention bonus project. Although we are still awaiting Federal approval, we did have some activity around the project as Clay Weidner from DODD did provide us some draft FAQs that we are sorting through in preparation for the rollout of the project when it is ready to go. It is obvious there's going to have to be a training component included to make sure that providers fully understand the project and how to opt in, report, distribute payments, etc... Once those materials are ready we will work with all of you to make sure you are ready to go.

Provider Relief Fund: If you received more than \$10,000 in PRF money between 1/1/21 and 6/30/21, then you will need to report during this next phase. Reporting opens next Friday. [You can access the reporting portal by clicking here.](#) Email Christine with any questions!

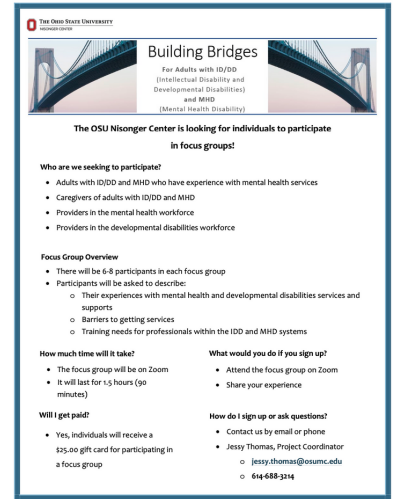

COVID-19 Testing Results for Reportable MUIs			
Negative	Pending	Positive	Total
1,142	0	1,647	2,789

- 1,647 people served have tested positive for COVID-19 and been hospitalized. There were **5 additional positives** since the 6/17 report.
- There were **5 additional hospitalizations** since the 6/17 report. This is a total of 2,611 people hospitalized and tested for COVID-19.
- A total of 2,789 COVID-19 reportable MUIs have been filed as 178 individuals were never hospitalized but COVID-19 was suspected or later determined as their cause of death.
- 385 people served have passed away who have tested positive for COVID-19. There were **0 additional confirmed deaths** since the 6/17 report.

Impacted Counties/Developmental Centers:

- There are 87 counties and 8 developmental centers with COVID related MUIs (CADC, CDC, GDC, TDC, MVDC, SODC, WDC and NODC).
- Franklin had the most people hospitalized and tested with 272 followed by Cuyahoga with 266.
- Cuyahoga had the most people tested positive with 168 and Franklin had 150.

Testing Demographics:

- Males accounted for 59.03% of those tested and females 40.97%.
- Ages of people tested ranged from 11 months to 95 years. The average age was 54 years. The most common ages are 59.
- The breakdown of people tested by race is:
 - Black or African American-14% (60% positive testing rate)
 - Other Race -2% (56% positive testing rate)
 - Unknown-5% (52% positive testing rate)
 - White/Caucasian 79% (59% positive testing rate)

COVID-19 Deaths:

- The mortality rate of those passing from COVID-19 (385) and the total people served (98,956) is 0.389%.
- The ages of those who died range from 11 months-95 years of age.
- The average age of the person who died was 60 years old.
- A total of 70 counties and 4 DCs (CDC, MVDC, NODC, TDC) have reported COVID-19 deaths.
- Franklin has the most confirmed COVID deaths with 30.
