<u>Dustin Wright:</u> Ohio's DD community is in shock and mourning this week with the passing of Dustin Wright, Founder/CEO of Disability Cocoon and leader of many other tech-related initiatives in Ohio and nation-wide. Dustin's name was synonymous with the Technology First initiative in Ohio and his passion, knowledge, and energy has been invaluable in launching tech-related supports. He was kind, gracious, innovative and always eager to help or lead in any way he could. His passing is a huge loss to our field, and we extend our deepest condolences to his family, friends and loved ones. <u>Behavior Support Rule:</u> This week, DODD published its revamped <u>Behavioral Support</u> section of their website. The new website has all of the behavior support content in one area and has been updated to reflect the revised rule which, goes into effect October 1. As a reminder, through Sept 30th, DODD will be offering training on the rule – either in-person, virtual, or online. There will be no citations issued unless there is a violation of rule 5123-2-06. After Oct 1st, there will be citations issued when there is substantial non-compliance. And your policies and procedures will need to be updated to reflect the changes regarding the rule and HRC. County boards and ICF's need to start identifying and revising existing plans if they are not in compliance with the updated rule. This needs to be completed by June 30, 2023. So members may want to navigate over to the department's site for any resources needed, including any trainings required. Please contact <u>Rachel</u> with any questions.

MRC: This week the DODD put out a notice that effective July 1st, email alerts will now be sent to any agency provider who is assigned to be the Daily Billing Unit provider in the Medicaid Services System for an MRC site when a change is made for HPC or OSOC services. This email will alert MRC providers that a change to HPC/OSOC services being delivered has occurred. Just reminder that if the provider does not mark the month complete box from 2019, 2020, and up to June 2021, and the result is below or above, there will be issues with re-billing due to timely filing. There have been a few small issues with errors below the 3% that are getting fixed. This new email system is intended to allow for much needed communication between county boards and providers. JFS Workforce Group: Last month, DODD announced that the state of Ohio would be convening a new work-group comprised of state-level executive agencies to focus on solutions to the workforce shortage across Ohio's human services fields. The first action of this task-force was distributing a survey to stakeholders, soliciting ideas on ways to address the workforce crisis. Earlier this week, Ohio Job & Family Services (JFS), the lead agency for the working group, reached out to us in response to our survey feedback, inviting OPRA to participate in the group's meeting later in the month. We encouraged members to also complete the survey, and we know that many did, so please let us know if JFS has reached out to you about sharing feedback at their upcoming meeting. We would love the opportunity to collaborate and coordinate with the membership on any potential communication with the workgroup. <u>Provider Relief Fund:</u> "Providers who received one or more Provider Relief Fund (PRF) payments exceeding \$10,000, in the aggregate, from January 1, 2021 to June 30, 2021 must report on their use of funds during Reporting Period 3 (RP3). The PRF Reporting Portal for RP3 is now open and will remain open through September 30, 2022. HRSA will host technical assistance webcasts for new and returning reporting entities. Providers must register to attend:

- New Reporting Entities: PRF Reporting Requirements Intro: July 12, 2022, 3:00-4:00 PM ET.
- Information for Returning Reporters: July 13, 2022, 3:00 4:00 ET."

<u>Ability One:</u> Late last month, the Ability One Commission, which oversees the Federal jobs program, released their strategic plan for the next several years. Ability One contracts focus on federal production contracts to employ people with vision impairments and other significant disabilities. The plan focuses on better/more CIE outcomes and revisions to the JWOD act, which require disability-specific ratios for Ability One contracts. <u>Click here to read the plan.</u>

COVID-19 Testing Results for Reportable MUIs

- 1,658 people served have tested positive for COVID-19 and been hospitalized. There were 6 additional positives since the 7/1 report.
- There were 6 additional hospitalizations since the 7/1 report. This is a total of 2,622 people hospitalized and tested for COVID-19.
- A total of 2,800 COVID-19 reportable MUIs have been filed as 178 individuals were never hospitalized but COVID-19 was suspected or later determined as their cause of death.
- 386 people served have passed away who have tested positive for COVID-19. There was 1 additional confirmed death since the 7/1 report.

Impacted Counties/Developmental Centers:

- There are 87 counties and 8 developmental centers with COVID related MUIs (CADC, CDC, GDC, TDC, MVDC, SODC, WDC and NODC).
- Franklin had the most people hospitalized and tested with 273 followed by Cuyahoga with 268.
- Cuyahoga had the most people tested positive with 170 and Franklin had 151.

Testing Demographics:

- Males accounted for 59% of those tested and females 41.%.
- Ages of people tested ranged from 11 months to 95 years. The average age was 54 years. The most common ages are 59.
- The breakdown of people tested by race is:
 - Black or African American-14% (60% positive testing rate)
 - Other Race -2% (56% positive testing rate)
 - Unknown-5% (52% positive testing rate)
 - White/Caucasian 79% (59% positive testing rate)

COVID-19 Deaths:

- The mortality rate of those passing from COVID-19 (386) and the total people served (98,956) is 0.390%.
- The ages of those who died range from 11 months-95 years of age.
- The average age of the person who died was 60 years old.
- A total of 70 counties and 4 DCs (CDC, MVDC, NODC, TDC) have reported COVID-19 deaths.
- Franklin has the most confirmed COVID deaths with 30.
