ICF QSOs and Guidance: We would like to try to clarify some of the CMS and CDC guidance that has come out in recent weeks. The guidance that came out has been extremely confusing and to that end, OPRA has developed these slides that hopefully will provide more clarity. Essentially, ICF providers will need to determine whether your facility is a 'healthcare setting' and develop its policies according to which category you would fall into. And some of you that operate multiple facilities may find that you fall into a healthcare setting at one facility based on the services you provide there (skilled care) and another facility may fall into the non-healthcare setting. We at OPRA will of course support the decision that you make and assist with providing as much information as possible and continue to provide updates on this as we go down this road. Member Meeting: Over the past few years there has been an intentional effort to review our code of regulations to make the necessary changes to reflect best practice and the evolving needs of our membership. Leading the way to suggest and formulate the changes has been the Board of Directors and Governance Committee Recommendations were made to our Board of Directors to go from 8 districts to 7 and to change our elections to have one seat from each of our districts up for election every year. We would like to thank our Board for their thoughtful approval of these recommendations. At the Annual meeting, the members in attendance unanimously approved the changes to the code. If you are a member in district 8 which is not geographic in nature but consists of providers who operate in multiple counties. With the elimination of District 8 you will now join one of our 7 geographic districts. The geographic location you choose can be determined by the home office of the organization's CEO/Lead employee. If you have questions about this or you would like to choose a different district, please contact **Sonya** to make the request and we will do our best to make it work. **OOD CESP Requirement:** Last week we mentioned our discussions with OOD around service delays and capacity struggles, most specifically with the Supported Employment-Job Development service. After some discussion, OOD has agreed to try a 'CESP Program' model, where a CESP-certified professional could supervise or mentor other staff who do not yet have the certification to provide this important service. Earlier this week OOD shared this draft proposal for the trial project. We will be hosting guests from OOD at the next Day & Employment Services committees and will be meeting with them prior to finalize this proposal, so please reach out to Scott with any questions or feedback on the proposal. Additionally, OOD announced yesterday that due to the transition to the new fee
