<u>Governor's Meeting</u>: As Governor DeWine prepares to unveil their executive proposal for Ohio's operating budget for SFY24-25, our budget coalition had the opportunity to meet with his office, as well as OBM Director Kim Murnieks and DODD's Director Kim Hauck. Representatives from the budget coalition were able to further make the case for the need for support in the state budget for Ohio's disability services and raise wages for direct support staff.
