Budget Testimony: This week saw some incredible advocacy and testimony in the Ohio House Finance Sub-Committee on Health and Human services. Director Hauck testified to the subcommittee on Tuesday morning, and continued to face questions from the committee regarding the discrepancy in wages between staff at state-run Developmental Centers and private provider agencies. Following the Director's testimony, our budget coalition testified in support of our budget ask and the need to build on the Governor's proposal. The panel included OPRA's Pete Moore as well Gary Tonks of the Arc of Ohio, Debbie Jenkins of OHCA and Adam Herman of OACB. Just prior to the the testimony, Gongwer published this interview with the coalition representatives. Thank you to everyone who submitted written testimony and huge thanks to OPRA Members Becky Sharp from Open Door, Dan Conners for St. Joseph Home, and Ashley Brocious from RT Industries for providing in-person testimony on Tuesday! If you are interested in providing in-person testimony next week, please reach out to either Pete or Christine. Following the week of testimony, the sub-committee chair, Rep. Carruthers, expressed her support to build beyond the current \$16/hr wage proposal, but acknowledged their various funding priorities and the challenges in allocating their limited resources. <u>CMS and PHE Unwinding</u>: This week we had our national call with CMS. And we began this meeting discussing many of the challenges providers are experiencing in relation to the end of the Public Health Emergency. At this time CMS is preparing guidance related to the end of the public health emergency, but we still do not have clarity on the big issues such as masking and vaccine mandates. Just a reminder the PHE does end in May and things may be moving quickly here soon. We will continue to push for clarity and will keep members apprised of any new information from CMS. <u>Blueprint:</u> Following the stakeholder-wide pointed feedback to the current proposal from DODD/Milliman, DODD is pulling stakeholder back together to chart a path forward. Next week DODD will convene the Quality Program Blueprint sub-committee. This group had been meeting prior to DODD concluding stakeholder work and developing their current proposal. DODD is hoping to implement a pilot project by the end of 2023, but there is still much to work through if DODD is to get system support for the project. Additionally, DODD has scheduled a meeting for April 19th, to unveil the Employment/Vocational part of the Blueprint proposal. This will be crucial in evaluating the overall impact of both proposals and which elements we can support and/or oppose. Please contact <u>Scott</u> with any questions or feedback.


