<u>House Finance Committee:</u> House Bill 33, the state biennium operating budget bill, has now been brought to the the full House Finance Committee. As the committee holds hearings, we are seeking support to build beyond the Governor's proposed DSP wage increase to \$16, and achieve our ask of a 50% rate increase for waiver services and 40% increase in direct ICF services. Budget amendments are due April 5th. While we have seen great support to increase DSP wages, with several reps calling for a \$20 average wage, while other are likely concerned about the costs of such an increase, and others are likely to vote no on any budget the committee presents. We would like to give a huge 'thank you' to everyone who traveled to Columbus to give in-person Testimony this week, including Melinda Cale, Holly Cordez, Jason Harris, Dr. Jason Jolly, Tony Thomas, Mary Nix and Michelle Madden. We would also like to thank those of you who submitted written testimony. While there were plans for further hearing next week, including from our budget coalition panel, we are now hearing the committee may postpone next those hearings.
