

The Basics

There are **five** different state budgets reviewed and passed by the Ohio General Assembly. Funding for services paid for by the Ohio Department of Medicaid, Ohio Department of Developmental Disabilities, and Opportunities for Ohioans with Disabilities are appropriated through the **main operating budget**.

THE FIVE BUDGETS

- 1. Main Operating
- 2. Transportation
- 3.Bureau of Workers Compensation
- 4. Capital Appropriations
- 5. Capital Reappropriations

Budget Lingo

APPROPRIATION:

The assignment of funding to each line item in the budget.

CONFERENCE COMMITTEE:

A small committee made up of House and Senate leadership that meets at the end of the process to reslove differences between the House and Senate-passed versions of the bill.

LINE ITEM:

The budget is presented as a line item budget. Line items are divided by funding source, state department, department division, and purpose for spending. A line item can pay for a specific program or a grouping of programs. The Governor retains the power to veto each line item. May also be referred to as an appropriations line item (ALI).

BALANCED BUDGET RULE:

A budget-writing rule prohibiting the state from passing a budget that spends more money than is available in state revenue.

GENERAL REVENUE FUND (GRF):

A state fund from which most state agencies receive financing. Money in the GRF is available for expenditures on any lawful public purpose specified by the General Assembly. GRF comes from sales and use tax, income tax, business taxes, other taxes, and lottery profits. GRF is one of six funding sources used to pay for state government operations.

STATE FISCAL YEAR (SFY):

The State of Ohio's fiscal year runs from July 1 to June 30th. Each operating budget covers two fiscal years.

The Budget Process

Governor introduces an executive budget

Executive budget is turned into a bill and introduced in the House of Representatives

Bill referred to the House Finance Committee and it's Subcommittees

Bill is voted out of Committee and sent to the House floor for a full House vote

Bill is sent to the Senate

Bill is referred the Senate Finance Committee and it's subcommittees

Bill is voted out of Committee and sent to the Senate floor for a full Senate vote.

Bill is sent to Conference Committee

Conference Committee meets to resolve bill differences

Both the House and Senate vote to accept changes and sends bill to the Governor To begin the budget process, the Governor introduces an executive budget to fund the state government. This request is turned into a bill and is introduced in the Ohio House of Representatives. The budget must be introduced by **March 15th**. After the bill's introduction, both chambers of the General Assembly host hearings where the public testifies on the various parts of the budget. Legislators make changes based on testimony and constituent feedback and vote on the bill. Once both chambers pass the bill, the bill goes to a Conference Committee to resolve differences between the versions of the bill passed by each chamber.

After the conference committee approval, the bill returns to each chamber for a final vote. Then the bill goes to the governor for review and signature. During this review, the governor may veto specific appropriations or language in the bill. Per the Ohio Constitution, the governor must sign the bill by **June 30th** so the budget goes in to effect on July 1st. The General Assembly has the power to override any vetos but this is rare.



PUBLIC TESTIMONY

At each green bubble, there is an opportunity for the general public to provide written or in-person verbal testimony on the budget bill. Typically, OPRA and OPRA Members provide testimony at these public hearings.

Governor authors line-item vetos and signs bill into law. Budget is officially complete.

Committees of Jurisdiction

These Committees and Sub-Committees oversee the budget line items for DODD and OOD services. These Committees are considered "Committees of Jurisdiction."

OPRA Members who deliver services in these committee members' districts should prioritize advocacy efforts with these offices.

Budget Advocacy

There are many ways to advocate during the state budget process. Not all advocacy methods have the same amount of impact.

INDIVIDUAL LEGISLATIVE MEETINGS

The most effective advocacy tool is hosting legislators to see services being delivered in person. Meeting your legislator in Columbus is also highly effective.

Getting a meeting during budget time can be tricky depending on the office, but many offices will participate in virtual meetings. This one-on-one method allows for the most relationship-building with your elected officials.

COMMITTEE HEARING TESTIMONY

Testimony is also an effective advocacy tool. Testimony is provided as written testimony or verbally in-person at a committee's public hearings at the Statehouse. A copy of your testimony and a witness slip must be submitted to the committee chairperson's office at least 24 hours prior to the hearing. Verbal testimony is usually limited to five minutes with the opportunity for members of the committee to ask follow-up questions. There is no limit on the length of written testimony.

EMAIL

Email is an easy way to share your message with your legislator. Be aware, during budget season, legislators receive hundreds of emails a day and you may not receive a response. If you are trying to make new relationships with your legislator, individual legislative meetings are more effective.

PHONE CALLS

Calling a legislator's office is an easy and medium-effective way to advocate. When calling in the Senate, you may get a staff member whose main duty is scheduling and may not have a in-depth knowledge of an issue. If you want to discuss an issue further, you can request a follow-up call or meeting with a legislative aide who may be more knowledgeable.

ELECTRONIC ADVOCACY FORMS

Electronic advocacy forms are easy ways to connect with legislators. However, most forms don't offer a lot of opportunities to customize your message. These forms have some effectiveness, but other options are more efective.

Budget Advocacy

Do's and Don'ts of Budget Advocacy

Legislators are humans and are moved by personal stories. The most effective message blends data with personal stories on way the budget process is important to a certain cause. Empowering your staff, the people you support, and their families to explain how the budget impacts their lives also greatly increases effectiveness. **DO** make sure to spell out any acronyms specific to services for Ohioans with developmental disabilities.

DO send a thank you to the legislator or staff for their time.

DO get your staff, people served and their families involved!

DO be as concise as possible in delivering your message.

Where to focus your advocacy:

The elected officials who represent **where you live**

The elected officials who represent **your main office**

The elected officials who represent your **service delivery area**

The elected officials of the committees of jurisdiction

DON'T assume your legislator is an expert in DD or Medicaid services. Most legislators are unfamiliar with the in-depth details of service delivery. Some may have a basic understanding of Medicaid and services for people with I/DD.

DON'T be offended if you are making a legislative appointment and only speak to a legislative aide. Aides can have just as much influence on the legislative process as the legislator does.

The personal narrative supports an agency narrative. Together, both narratives serve as a "sales pitch" to legislators on why they need to invest more state general revenue fund dollars in the services the agency provides. The personal narrative humanizes the importance of your services and why legislators should invest in them.

The questions below will help you begin to craft a good personal narrative. In most legislative meetings you won't have the opportunity to address every question, but it is still good to have an answer to each to be prepared.

Why are the services or employment opportunities important you?

What is a specific example that highlights how important the agency's services are to you?

How would your life be impacted if the agency and their services were no longer available? Be specific!

Building An Agency Narrative

The agency narrative is one of the most important tools in legislative advocacy. Both narratives serve as a "sales pitch" to legislators on why they need to invest more state general revenue fund dollars in the services the agency provides. In most legislative meetings you won't have the opportunity to address every question, but it is good to have an answer to each to be prepared.

This is a non-exhaustive list of suggestions.

How many people do you serve?



What is the age range of the people you support?

Where do the people you support live?

What types of disabilities do the people you support have? What are their support needs?

What do the families look like of the people you support? Older parents? Younger parents? Only siblings?

How many people do you employ?



What is the average length of time people have been employed with you?

Building An Agency Narrative

This is a non-exhaustive list of suggestions.



What makes your agency different than other businesses in your area?

Is there a part of your agency that differentiates your agency from other I/DD agencies in the area? What is it?

Do you have partnerships with other community organizations or businesses? Employment opportunities for people you support? Religious institutions, local fraternal groups, etc.

Are you the largest employer in your area?

How do you compare in terms of wages and job opportunities to other employers in your area?

Number of open positions and recent turnover

Average wages for different positions

How have you changed service delivery over the years to remain open?

How have services grew or shrank in size over the past few years?
