Budget Update: Earlier this week, Governor DeWine signed House Bill 33, Ohio's state biennium operating budget, into law. Ohio's DD services will see a total increase of over a billion dollars from local, state, and federal sources over the next two years. Governor DeWine issued 44 line-item vetoes on the budget, including language around statewide average wages for DSPs. OPRA anticipated this veto as it is consistent with Governor DeWine's previous budgets. The veto does not impact the funding the General Assembly appropriated and we believe DODD will increase rates in a manner consistent with the vetoed language. You can read Governor DeWine's full veto message here (see page 6). OPRA wants to thank the OPRA members who submitted written testimony to the various committees of jurisdiction this budget! We also want to thank the OPRA members, families, and people served who testified in person at the Statehouse! We could not do the advocacy without you! A few notes regarding the rate increases;

- Funding is meant to increase rates to a level to support a statewide AVERAGE DSP wage of \$18/hour starting on 1/1/24 and a statewide AVERAGE DSP wage of \$19/hour on 7/1/24* for waiver services including HPC, PD-HPC, OSOC, Day, Employment, NMT, Transportation, Shared Living, Remote Support.
- Includes increases to various add-ons, home-delivered meals, and money management.
- Rate tables for all of the services will be released by mid-August.
- Rate assumes increased funding for frontline supervisors.
- For ICFs: Funding is meant to support a statewide average DSP wage of \$17/hour starting 7/1/23 and a statewide average DSP wage of \$18/hour on 7/1/24*

<u>Blueprint:</u> Thanks to everyone who attended yesterday's Day & Employment Services committee meeting. A significant portion of the meeting was dedicated to a review of the technical guide for the upcoming ADS Quality Pilot project. <u>Rule Review:</u> This week DODD sent out two rules that are up for the 5 year review. Rule 5123:2-1-03 regarding locally funded transportation, and Rule 5123-12-01 regarding video conferencing by the Ohio Developmental Disabilities Council. Both rules can be accessed on the <u>Department's website</u>. Comment for both rules is due July 20th.
