ANCOR Retreat: Some of the OPRA team had the opportunity to travel to Denver this week for the Ancor State Association Executive retreat. It was a great opportunity to meet with professionals from other states about the challenges



they are facing and also hear about ways to improve how we support our members. Ohio is definitely not unique when it comes to workforce challenges and navigating bureaucracy and policy changes.

Quality Pilot Application (Delay): We are still awaiting approval from CMS for the ARPA dollars to fund the ADS Quality Pilot. DODD is expecting word as soon as today as to whether the project can move forward. We should know more by the beginning of next week. <u>Policy Committee:</u> Thank you to everyone who attended, participated and persevered through our shaky internet issues for this week's Policy Committee meeting. We gathered great feedback from the committee to inform our advocacy and approach to DODD's Waiver System Redesign being administered by contractor, DeLoitte. Through live-polling and discussion we captured several issues and recommendations for people with disabilities as they travel down the path towards waiver services, including discussions on the assessments, provider referral, ISP development and more. We also reviewed the regulatory reform proposals developed during the budget coalition process and prioritized them for renewed action and advocacy. We will be sending a surveymonkey to the policy committee next week, corresponding to the live polling questions asked to gather more feedback from the membership.

<u>New COVID Variant:</u> There have been several reports of a <u>new COVID variant, known as 'Eris'</u>. We encourage members to review their infection control policies and to continue to be as proactive if/as cases begin to spread.
