<u>Pre-Voc and Employment Group</u>: Last week, DODD held an in-person stakeholder meeting to continue previous discussions around pre-vocational and employment services. Part of this work includes the potential of bringing up a new service/rate specifically designed for transporting people to their jobs in the community. Ahead of the next workgroup meeting, which will be solely focused on this topic, DODD and contractor Milliman have put together a short data request for providers who have utilized a usual customary rate (UCR) to provide transportation. We hope providers who have developed a methodology for a UCR (likely to provide 'commercial transportation') will participate in the survey, which DODD plans to distribute as soon as today.

<u>ADS Pilot:</u> Following the CMS approval of funding to support the project, applications for the project will begin to be accepted on October 12th at 2pm. Given the interest in the pilot and the 'first come, first served' nature of the application process, it will be crucial for applying providers to complete their applications beforehand and submit as early as possible during the application period, which closes on October 16th. <u>Click here to visit DODD's webpage</u> and download the application packet. <u>Speaker of the House:</u> This week, the US House of Representatives removed Speaker Kevin McCarthy from the Speaker role. This leaves the US House in a moment of great turmoil as no legislative work, including avoiding another federal government shut down, can happen until a new Speaker is selected.
