**DD Budget Coalition Data Collection Efforts:** The group of DD associations developed a short survey for agency providers to share their experience with the state budget increases' impact on services. The survey will be distributed quarterly to monitor the budget's impact overtime and to help develop the next budget ask. **HB 321:** HB 321, sponsored by Representative Click and Lorenz, establishes a statewide first responder database to hold voluntarily submitted information on "special needs" of residents with disabilities. The information in the database will be accessed by first responders to minimize adverse interactions with Ohioans with disabilities. On February 7th, OPRA submitted testimony to the Ohio House Homeland Security Committee in support of the bill. [You can learn more about the bill and find OPRA's testimony here.](#)

**Disability Community Act (H.R. 7267):** This bill would provide a temporary higher Federal medical assistance percentage (FMAP) for Federal expenditures under the Medicaid program that are associated with the cost of compliance with the DOL's "overtime rule" with respect to services furnished in certain intermediate care facilities or home and community-based services furnished to individuals with intellectual and developmental disabilities. Bill language has not yet been posted to Congress.gov. **Healthcare Committee:** The Healthcare Committee will be meeting next Thursday from 10 to noon. The first portion of the meeting will include a discussion with one of our pharmacy partners on what to look for in an EMAR and then a demo from two EMAR vendors (Therap and iCareManager). The second portion of the meeting will discuss potential changes to Ohio's Do Not Resuscitate orders. **Pre-Voc/GES/NMT:** We were expecting to participate in the final meeting of the 'Pre-Vocational and Employment Services', hoping to see the final proposal language and rate models for the eventual Basic Employment Skills Training (BEST), Group Employment and a new transportation service, specific to helping people access community employment. The meeting wound up being canceled, as DODD needed more time to finalize the proposed rate models. We are eager to see the proposals, especially as they relate to any new rate models or enhancements. **Training Feedback:** OPRA is working on our training catalog and resources for 2024 and beyond.
