OOD Fee Schedule: Earlier this morning, OOD sent out a 'feedback and response' document, outlining their service and rate proposals for the upcoming fee schedule. The proposals include a 4.5% increase to all OOD services, additional rate increases for Summer Youth Work Experience services, the re-introduction of SYWE-Career Exploration to the fee schedule, and a proposal for a 'benchmarked' approach to Pre-Employment Transition Services. We actively welcome feedback from members on the proposed changes, especially how the 4.5% proposal aligns with your expenses and rate adjustments through DODD and the Pre-ETS proposal. OOD is expecting the first round of feedback within the next few weeks, so please provide your thoughts to Scott as soon as possible.

<u>Rules:</u> The OPRA team has been monitoring and working on updates to several rules including the Investigative Agent rule, <u>which will get a hearing on May 14th</u>. OPRA and OPRA members have also been participating in workgroups to address the Waitlist and the MUI rule. The Employment service and the Specialized Medical Equipment rules just out for clearance are expected to be filed soon.

Employment Quality Services Project: The application period for this project opened at 2pm this past Tuesday and discussions with DODD indicate that almost 60 providers applied for the funds. As we've discussed, the funding available limits this project to likely around 30 providers who will be selected to participate. We wish the best of luck to all of the OPRA members who applied. Additionally, we know that DODD will be releasing an RFP for a capacity-building project for Group Employment Supports. This project will pair Subject Matter Experts with providers looking to build their Group Employment services. Keep a lookout for next week's Memo Monday for information on that project.
