<u>Conference</u>: Thank you to everyone who joined us in Toledo for our Spring Conference/Business Retreat. We are so grateful to all of the attendees, presenters, vendors and sponsors that helped make this experimental event a success. It was great to spend time with our members in a new city for our conference, and we were excited to bring you a new event experience. A special thanks to Toledo's community and business leaders for welcoming us in the Glass City last week!



<u>OOD Fee Schedule:</u> Earlier this week, OOD held a meeting of their Fee Schedule workgroup to review the feedback to their proposal shared a few weeks back. <u>OOD shared this presentation</u> to provide some additional context to the proposed rate increases. They are now proposing an additional 1% 'across the board' rate increases (equaling a 5.5% total increase) as well as the targeted proposals around SYWE and Pre-ETS. We are expecting to see the revised proposal shortly.

<u>Updated Federal Regulations Presentation:</u> On April 26th, Christine presented on numerous recently released federal regulations. Christine updated this presentation to include a slide on the applicability of the FTC's jurisdiction over non-profits and whether or not the ban on non-compete agreements applies to non-profit organizations. <u>You can review the updated slides here.</u>

<u>Compensation, Benefits, and Turnover Survey:</u> OPRA's biennial survey has been revised and revamped with a new vendor-Compensation Resources. The survey has been redesigned for easier completion and hopefully will provide a more useful report for you to benchmark your compensation and benefits practices. <u>HR Committee:</u> The OPRA HR Committee is scheduled to meet next Thursday from 10am to noon. Representatives from the Ohio Attorney General's BCI office will be joining the committee for the first hour to discuss background checks and Rapback. During the second hour, representatives from Compensation Resources will join the committee to discuss the revised Compensation, Benefits, and Turnover survey. <u>Staffing Rule:</u> CMS has published the final <u>nursing home staffing regulations</u>. There is a provision in the rule regarding payment transparency around direct care compensation, as well as timeframes around the minimum nurse staffing requirements. OPRA will continue to update our members as more information becomes available. Please refer to this <u>CMS Fact Sheet</u> regarding the rule.
