**Overtime Rule:** Last week, 12 plaintiffs filed a complaint in a federal court in Texas to vacate and set aside the US Department of Labor's recent Overtime Rule. Plaintiffs specifically selected this court as it is the same court that issued an injunction on the 2016 proposed rule and hope will rule in a similar manner. The plaintiffs are seeking expedited review of the case given the first set of increases are set to take effect on July 1, 2024.
