ODH Survey Update: The Ohio Department of Health provided a recent update on ICF surveys.

- From June to October, the average time between surveys was 17.42 months
- From June to October, 308 ICFs were surveyed, with 112 currently overdue
- ODH is facing staffing shortages but has hired new surveyors, bringing their total to 144, 31 short of ODH's goal
- OISP continues to be a focus during surveys

COVID Tests: The US government is providing free COVID-19 tests to households this year. Every US household is eligible for 4 tests. Visit [COVID Tests.gov](#) to register. Additionally, there are tests available that are more accessible for people with disabilities (while supplies last). To order the accessible tests, please click [here](#). Tests distributed are able to detect the dominant variants that are circulating, including the subvariant KP.3.1.1 and KP.3.
