The rule would still go through it's comment period and JCARR. Please let <u>Rachel</u> know if you have any questions.

<u>Election Day:</u> The November 5th election is right around the corner on Tuesday. You can find resources for voters with disabilities <u>here</u>. Also, as mentioned on the morning call, <u>here is the directive</u> from the Ohio Secretary of State impacting who can assist voters with disabilities to vote via absentee ballot box.

<u>Settings Webinar:</u> Yesterday (10/31), DODD held a webinar outlining the federal and state requirements for compliance with the <u>HCBS settings rule</u>. The webinar highlights some of the concerns we have had with DODD's recent interpretations and enforcement of the settings rule. 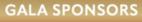
