<u>Proposed 14c Rule:</u> Earlier this week, the US Department of Labor's Wage and Hour Division released a proposed rule to phase out the use of 14c certificates, which allow for commensurate wages for workers with disabilities. The proposed rule outlines the historical and policy developments that led the DOL to preliminarily conclude that the certificates are no longer necessary to 'prevent curtailment of employment opportunities' for people with disabilities. Given the changing administration and potential challenges to DOL's authority to make this change, the future of this rule-making is very uncertain. <u>EVV:</u> Yesterday, the Ohio Department of Medicaid (ODM) shared an update on the timeline for turning on claims denials based on insufficient EVV units. ODM will begin turning on claims denials in multiple phases with phase one starting on March 1, 2025. The first phase of denials will NOT impact DODD services. <u>DOL Overtime Rule</u>: As OPRA previously shared a few weeks ago, a Texas Court recently struck down the US Department of Labor's proposed increases to the overtime exemption threshold. Last week, the Biden administration officially filed their appeal of the court's decision. With the pending change of administration and holidays, it seems unlikely the court will have the chance to have a hearing or move the appeal through the legal process before the Trump administration takes over. <u>You can read more about the appeal here.</u>

HB 676: Pediatric Prescribed Extended Care (PPEC)-Last week, the House Families and Aging Committee hosted the second hearing for the bill that would create PPECs. Rep. Baker is having on-going discussions with the Ohio Department of Medicaid about funding and the Department of Health on certain licensure requirements. We do not anticipate the bill will pass this General Assembly but think we could see a version in the next budget. If you are interested in the legislation, please reach out to Christine.
