<u>EVV:</u> The Ohio Department of Medicaid has released their long-awaited roll out plan for claims denials related to electronic visit verification (EVV). <u>This formal announcement</u> states that claims denials for covered DODD services will begin on 10/1/25. With the rollout of claims denials, ODM is re-establishing their EVV stakeholder group for associations. The first meeting is tentatively scheduled for next month. Christine will be the OPRA liaison for this group. If you have any questions, thoughts, or otherwise would like to share your EVV grievances, <u>please reach out.</u>

<u>Federal Funding:</u> During this whirlwind week, we saw several parties bring lawsuits against the Trump administration to halt the funding freeze announced Monday evening. A federal judge issued a temporary stay to prevent the order from taking effect until a hearing could be had on Monday, 2/3/25. Following this ruling, <u>the administration rescinded Monday's memo</u>. This means there will be no immediate freeze on federal funding for the covered grants and programs. We will be keeping a close eye on these reviews and will share updates as we get them.

<u>Art Studios:</u> Last Friday, DODD held a meeting for providers of art studio services, partly to navigate the future of these services, especially given the rule proposals for BEST and Group Employment Supports. These meetings will be ongoing and we look forward to the continued dialogue on these important and meaningful services.

<u>ICF Trade Association Meeting:</u> This week we participated in the Ohio ICF trade association meeting with both the DODD as well as ODH. During the meeting, ODH stated that they will be focused on completing ICF recertification surveys. Over the last year ODH has worked to clear the complaint backlog from the pandemic. This year they will work to complete around 30 surveys per month beginning February 1st. Additionally, during the call DODD shared that they will be reconvening the ICF reimbursement group around March.
