This week the Ohio House Health Committee held a hearing on DODD and OOD's proposed budgets. Nine OPRA members provided in-person testimony and many others provided written testimony in support of the budgets and encouraged the committee to consider additional funding. Updates

Legislative This week the Ohio Senate Judiciary Committee held a hearing on SB 35 which would add supported decision making into the Ohio Revised Code. OPRA provided written testimony in support of the bill. You can watch the hearing here. Additionally, you can read the submitted testimony here.

> Early this week the US Treasury Department announced it would no longer be enforcing the Corporate Transparency Act's rules on filing beneficial ownership for corporations, LLCs, and LLPs who were based in the US. <u>Federal Budget:</u> Last week, the <u>US House passed their budget resolution</u>, directing the Dept of Energy and Commerce to cut \$880 Billion over the next decade, heightening the concern over potential cuts to Medicaid. The budget resolution still must be reconciled with the Senate's budget bill, which only directed \$1 Billion in cuts. We encourage members to utilize the <u>Medicaid Resource Center</u> developed by our partners at ANCOR to continue your advocacy as OPRA works with our national partners to advocate and educate on the importance of Medicaid in disability services.
