<u>Budget Testimony:</u> This week the Ohio House Finance Committee heard further testimony on HB 96, the State's Biennium Budget Bill. We want to thank all of the members who submitted testimony in support of the budget and further rate increases for disability services. In his 2025 State of the State address, Governor Mike DeWine highlighted Ohio's economic strength, noting the state has reached its highest employment levels, with over 81,000 private sector jobs added, totaling nearly 5.7 million employed Ohioans. To support families, he proposed a new child tax credit of up to \$1,000 for each child under seven. Emphasizing education, DeWine announced changes in higher education funding, basing allocations on course completion and graduation rates, and tasked new Lieutenant Governor Jim Tressel with developing "Ohio's workforce playbook" to enhance job readiness.
